

**ACTION:** Request approval to abate public nuisance items at the Thompson Property located at 3530 S. Kachina Drive. The applicant is the City of Tempe – Code Compliance.

**FISCAL IMPACT**: \$399 for abatement request: remove unregistered vehicle from driveway.

**RECOMMENDATION:** Staff – Approval of 180-day open abatement

**BACKGROUND INFORMATION:** City of Tempe – Code Compliance Section requests approval to abate items in violation of the Tempe City Code at the THOMPSON PROPERTY. The details of this case represent several months of correspondence for compliance with the property owner. Staff requests the approval of abatement of the following nuisance items under Complaint CE224335: remove unregistered vehicle from driveway.

#### **COMMENTS:**

Code Compliance is requesting approval to abate the Thompson Property located at 3530 S. Kachina Drive, in the R1-6 Single Family Residential district. This case was initiated 07/25/2022, after which Code Compliance has attempted to obtain compliance through correspondence with the property owner regarding violations of the Tempe City Code.

Without the intervention of abatement, the property will continue to deteriorate. It is therefore requested that the City of Tempe Community Development Hearing Officer approve a 180-day open abatement of this public nuisance in accordance with Section 21-53 of the Tempe City Code.

### FINDINGS:

07/25/2022 The Code Compliance Division received a complaint for unregistered/inoperable vehicle. I inspected property and observed an unregistered vehicle in the driveway. Notice to comply mailed to owner.

08/08/2022 I inspected property and observed the unregistered vehicle still in the driveway. Mailed final notice to comply to owner.

08/22/2022 I inspected property and the unregistered vehicle was still in the driveway. I also observed grass and weeds in the front and side yards gravel landscape. I mailed the owner a notice for all violations.

09/07/2022 Posted notice to property to comply or contact me 09/12/2022.

09/08/2022 Owner contacted me and let me know it was her husband's car who had passed in January and the title was thrown away by mistake. She was going to contact MVD to get a new one and was going to schedule a landscaper to come out. I granted her an extension.

09/26/2022 I inspected property and the property was not brought into compliance. I spoke with the owner, and she stated she was trying to donate the car and the landscaper had come out. I granted her more time to correct the violations.

10/10/2022 The owner called and said her landscaper had car troubles and would be out in a few days. She also stated she is still trying to get a title to donate the car. I granted her a few more days and told her if the landscape was not corrected and the

vehicle registered by the reinspection date, I would issue a citation.

10/14/2022 I inspected the property, and the landscape was corrected. I spoke with the owner, and she said her a/c went out, so she was working on that instead of getting her title to register the vehicle.

10/25/2022 Owner failed to register vehicle or remove from driveway after several extensions therefore, a Civil Citation was issued to the owner.

11/09/2022 Owner failed to appear for court.

01/06/2023 Posted notice of intent to abate to property and mailed to property owner.

### **RECOMMENDATIONS:**

I recommend an abatement of the nuisance violations at the property at 3530 S. KACHINA DR. due to property owner's failure to bring property into compliance with Tempe City Code 21-3.B.3. Laurie J. Thompson has been given ample time to come into compliance and maintain the property. The owner has been issued a civil citation and has failed to appear to court for the citation. There has been no indication that the property owner will bring the property into compliance. The property represents a health hazard and an eyesore to the community.

Without the intervention of abatement, the property will continue to deteriorate. I therefore make a request to the City of Tempe Community Development Hearing Officer for authorization to abate this public nuisance in accordance with section 21-53 of the Tempe City Code and authorization of multiple abatements for a period not to exceed one hundred eighty (180) days from the previous abatement order.

We are requesting Hearing Officer Authorization to abate this public nuisance in accordance with Section 21-53 of the Tempe City Code by removal and repair of:

An unregistered vehicle outside of or under a roof area not enclosed

As owner of the property, you have thirty (30) days after receipt of this letter to abate or correct any violation as described below. If the violation(s) have not been corrected, our office will proceed with the abatement process.

CC 21-3.b.3 REMOVE UNREGISTERED VEHICLE FROM DRIVEWAY OR REGISTER WITH AZ MVD.

Upon receipt of the Hearing Officer approval to abate this public nuisance, the necessary work will be performed at the expense of the property owner. The cost of this work will be \$399.20. In addition to the actual cost of abatement, an administrative charge of fifteen percent (15%) of the actual cost of abatement or three hundred (\$300) dollars, whichever is greater, for expenses incurred by the city for abatement procedures, and the cost of recording liens and releases will be charged. The recorded lien may bear interest at the legal rate of judgments in the State of Arizona. Administrative charges and the cost of recording liens and releases shall become a lien on the property whether or not the public nuisance is abated by the City.


