
Agenda Item: 4

ACTION: Request approval to abate public nuisance items at the Moreno Property located 2349 E. Bishop Drive. The applicant is the City of Tempe – Code Compliance.

FISCAL IMPACT: \$1474.20 for abatement request: front & side yard landscape cleanup, remove junk, trash & debris from front & side yards and driveway, remove inoperable vehicle.

RECOMMENDATION: Staff – Approval of 180-day open abatement

BACKGROUND INFORMATION: City of Tempe – Code Compliance Section requests approval to abate items in violation of the Tempe City Code at the MORENO PROPERTY. The details of this case represent several months of correspondence for compliance with the property owner. Staff requests the approval of abatement of the following nuisance items under Complaint CE224477: front & side yard landscape cleanup, remove junk, trash & debris from front & side yards and driveway, remove inoperable vehicle.

COMMENTS:

Code Compliance is requesting approval to abate the Moreno Property located at 2349 E. Bishop Drive, in the R1-6 Single Family Residential district. This case was initiated 08/01/2022, after which Code Compliance has attempted to obtain compliance through correspondence with the property owner regarding violations of the Tempe City Code.

Without the intervention of abatement, the property will continue to deteriorate. It is therefore requested that the City of Tempe Community Development Hearing Officer approve a 180-day open abatement of this public nuisance in accordance with Section 21-53 of the Tempe City Code.

FINDINGS:

08/01/2022 I initiated this complaint for inoperable vehicle in the driveway and deteriorated landscape which entailed grass and weeds growing in the gravel front yard. Notice to comply mailed to owner.

08/11/2022 I received an email from Marco Antonio Moreno asking for an extension due to him being out of state working. I emailed him back granting an extension.

09/22/2022 I inspected property and observed further deterioration. Final Notice to comply mailed to owner.

10/06/2022 I inspected property and observed no improvement so I emailed owner to bring property into compliance by 10/18/2022 or a citation would be issued.

10/18/2022 I inspected property and the landscape had been corrected. I left Mr. Moreno a voicemail to bring the remaining violation into compliance. I did not hear back from him.

10/25/2022 I inspected property and observed a new violation of trash/debris/boxes/bins/misc items in the driveway and side yard. The inoperable vehicle was still in the driveway. Final Notice with new violation mailed to owner.

11/08/2022 Owner failed to bring property into compliance therefore, a Civil Citation was issued to the owner.

11/23/2022 Owner failed to appear for court.

12/14/2022 The Code Compliance Division received an anonymous complaint for inoperable vehicle.

01/25/2023 Posted notice of intent to abate to property and mailed to property owner.

RECOMMENDATIONS:

I recommend an abatement of the nuisance violations at the property at 2349 E. BISHOP DR. due to property owner's failure to bring property into compliance with Tempe City Codes 21-3.B.3, 21-3.B.8 AND 21-3.B.1. Hector Carin Moreno has been given ample time to come into compliance and maintain the property. The owner has been issued a civil citation and has failed to appear to court for the citation. There has been no indication that the property owner will bring the property into compliance. The property represents a health hazard and an eyesore to the community.

Without the intervention of abatement, the property will continue to deteriorate. I therefore make a request to the City of Tempe Community Development Hearing Officer for authorization to abate this public nuisance in accordance with section 21-53 of the Tempe City Code and authorization of multiple abatements for a period not to exceed one hundred eighty (180) days from the previous abatement order.

We are requesting Hearing Officer Authorization to abate this public nuisance in accordance with Section 21-53 of the Tempe City Code by removal and repair of:

Upon receipt of the Hearing Officer approval to abate this public nuisance, the necessary work will be performed at the expense of the property owner. The cost of this work will be \$1474.20. In addition to the actual cost of abatement, an administrative charge of fifteen percent (15%) of the actual cost of abatement or three hundred (\$300) dollars, whichever is greater, for expenses incurred by the city for abatement procedures, and the cost of recording liens and releases will be charged. The recorded lien may bear interest at the legal rate of judgments in the State of Arizona. Administrative charges and the cost of recording liens and releases shall become a lien on the property whether or not the public nuisance is abated by the City.






