#### **PURPOSE:**

On behalf of my family, we wholeheartedly suggest and recommend that Mark McWhirter be named this year's Tempe Bike Hero. In fact, after reading more about him, I sincerely hope that you consider the idea of naming the award "The Mark McWhirter Tempe Bike Hero Award" in honor of his legacy and contributions to the city he called home for over 5 decades.

My description of 'Mr. McWhirter' (as my children called him) will never do justice to the humble greatness and love of learning Mark spread to those around him. His enthusiasm for many things, including biking, was contagious. I first met Mark as father of one of my son's friends-and fellow parent helper at a school function (maybe the Turkey Trot or Multicultural night?) Two of our children were in class with one another and as our paths would cross, we realized our families shared several values. One of those values was the importance of biking whenever possible instead of driving. As our families attended a school of choice, bussing was not an option.

How Mark and his wife, Katie managed to get 4 boys (one a toddler in the early years) to a school 3+ miles from home by 7:15 am is beyond my understanding. Our home was 1 mile away and this was quite a struggle for us and our 2 children to bike and get there on time. Though we would try as often as possible, sometimes I'd give up and say to my children, "Forget it, we're going to be late...get in the car!" I once asked Mark and his wife Katie, "How do you do it?!?" Their matter-of-fact-response was that biking is important and, "...our family is committed to biking to school at least once a week."

One day, we were picking our son up from a playdate at the McWhirter's when my husband and Mark realized they had a shared interest/passion...biking! They spoke about **biking groups** and events. Street biking vs. Mountain, etc. Again, being a curious person, I couldn't help but interject a few questions. I asked Mark how he 'keeps it all organized' with the 4 boys and 2 adults bikes. Where do they park? Do the boys ever misplace their helmets? I begged for pointers as our garage was starting to turn into a bike shed and we only had 4 total.

Mark then showed us the family's **AMAZING Bike Room**. **He had created** a bike storage space where there was literally a 'place for everything and everything was in its place'. "How?!", and "Where did the design and materials come from?!", I asked. The response was simply, 'Using what used to be a portion of the family's home garage, creativity, and ASU warehouse materials.' As I continued to launch question after question, he [poor Mark] proceeded to patiently **share all his knowledge of biking, bike safety, bike maintenance, Tempe's bike-friendly history, general Tempe history,** the fact that he attended Tempe High and looked forward to his sons attending Tempe High. Of course, they would be riding their bikes to school everyday- as he had. In fact one of his sons graduated from Tempe High last year and 2 sons currently attend Tempe High today (4th son attends McKemy).

There is no doubt in my mind that Mark McWhirter is this year's Tempe Bike Hero. It feels wrong yet necessary to share that unfortunately, Mark is no longer with us. Tragically, his life ended as a result of a bike accident on one of Tempe's bike friendly streets in a bike-friendly neighborhood.

I wish we had thought to nominate Mr. McWhirter years ago. Mark and his family regularly demonstrated the use of a bicycle as a significant mode of transportation. He consistently modeled riding as exercise, transportation, and leisure in his community. He encouraged his children and ours to ride:). His Bike Room design/idea would be a useful addition/ use of space for any family, school, organization, business, agency to make biking more accessible, logical, and possible. *Mark's name and his legacy are very much* 

woven into Tempe Bike History and it feels appropriate that they become tied to your wonderful program emphasizing Bicycle Safety Advocacy, youth involvement in bicycling, and bike-friendly elements in facility design.



#### **PURPOSE:**

This memo provides an update on the preparation of Tempe Tomorrow – General Plan 2050 including an overview of the feedback on the Circulation Chapter.

#### **BACKGROUND INFORMATION:**

#### Tempe Tomorrow – General Plan 2050

Arizona Revised Statutes (ARS) 9-461.06 requires that a municipality's General Plan be readopted or a new or updated General Plan be adopted and voter-approved every ten years. Based on the Council adoption of the General Plan 2040 in December 2013, and its voter ratification in May 2014, the General Plan 2050 will need to be adopted by the Council before December 2023, and put to the voters before May 2024.

Staff has been working on the development of General Plan 2050 since March 2022. Towards this goal, staff has conducted a robust outreach to the public and stakeholders, and has held several meetings and conducted surveys to gather their inputs. The Council-appointed Community Working Group (CWG) has provided guidance and advise in the preparation of the General Plan, and the Technical Advisory Group (TAG) has provided detailed input for its contents.

The draft GP 2050 provides the vision, goals, strategies, land use and residential density guidance towards achieving the required growth while enhancing Tempe's livability, sustainability, and resilience. Themes woven into the GP 2050 include developing Tempe as a leader in urban living; expanding pockets of urban activity centers or innovation "hubs"; and enhancing pedestrian, bike, and transit connections to produce a "20-minute City", and make Tempe a leader in cultural, sustainable, and climate-friendly policies.

#### Circulation Chapter

The purpose of the Circulation Chapter is to guide the future development of a city-wide multi-modal transportation system integrated with the City's land use, and sustainability and resilience plans, and community needs. The chapter identifies existing bicycle routes and facilities, pedestrian ways, existing freeways, arterial and collector streets, transit services and routes including light rail and streetcar, rail facilities including commuter rail and freight rail, air transportation, aviation, and other transportation issues as they relate to land use.

The Circulation elements are aligned primarily with the Tempe City Council priorities "Quality of Life", "Sustainable Growth and Development." and "Safe and Secure Facilities.








#### **PURPOSE:**

The purpose of this memo is to provide the Commission with a review of the draft 30% design of the Kyrene, Roosevelt, Farmer Bike/Ped Improvements Project which is proposing to connect the Western Canal Path at Kiwanis Park, to University Drive in downtown Tempe. The project's proposed improvements include protected and buffered bike lanes, 2-way cycle track, ADA directional ramps, upgraded crossings, ped signal on Baseline Rd, new sidewalks, wayfinding signage landscape, and lighting.

#### BACKGROUND INFORMATION:

In June 2010, Tempe began to develop a preliminary design concept for the North/ South Rail Spur Multi-use path located along the Union Pacific Rail Road (UPRR) corridor from University Drive to Knox Road. In 2012 the City of Tempe received a Design Assistance Grant from the Maricopa Association of Governments to study the full corridor extents of the project (University Drive to Knox Road, an alignment originally selected by MAG). That process concluded with a Narrative Report entailing a preliminary design recommendation in January 2015. Following completion of the preliminary design, the City then applied for CMAQ funds to complete design and construction of the project. A design team was hired in 2017 to develop and design construction documents for a buildable project that strives to provide a safe and low-stress north/south bicycle facility that spans the city limits. The 2015 Transportation Master Plan supports the implementation of this project including identifying the pathway in the Recommended Bicycle Pedestrian Improvements 2040 map and project list.

Two public meetings were held on October 3rd and 13th, 2018 to introduce the project, present the 30% design drawings, and collect public feedback on the project direction.

Due to UPPRR ROW constriants, cultural resource testing, and estimated costs totaling 3+ million, the original alignment had to be changed to not utilize the rail corridor. The new alternative alignment was approved by Council in 2019 and approved by MAG in 2021.. There will be two future meetings to solicit feedback from the public on the draft 30% designs at two meetings





#### **PURPOSE:**

The purpose of this memo is to provide the Commission with a review of the draft 30% design of the Grand Canal Connection Project which is proposing to connect the Rio Salado North Bank, Crosscut Canal, and Grand Canal Paths. The project's proposed improvements include a rest node, lighting, landscaping, new crosswalks, buffered bike lanes, a concrete multi-use path, and a new pedestrian signal at Mill Avenue.

#### CITY COUNCIL STRATEGIC PRIORITY:

#### **BACKGROUND INFORMATION:**

The Grand Canal Connection Project is identified in Tempe's Transportation Master Plan and in 2018, the Commission recommended staff put forward an application for the project to compete for Maricopa Association of Governments (MAG) Design Assistance funding. Tempe was ultimately awarded \$67,500 to develop a preliminary project assessment report and design concepts connecting Rio Salado North Bank Path with the Grand Canal Path.

In 2019, public meetings were held to gather feedback on the preliminary design concepts and a cost estimate was developed for the whole corridor. With the completed preliminary design report and cost estimate, staff pursued federal grant funding for not only the connections of the Rio Salado North Bank Path and Grand Canal, but also pursued additional funding for a third connection to the Crosscut Canal Path. Tempe was awarded the grant requests for both design and construction totalling \$2,304,914 in grant funding.

In the Summer of 2022, the City, in partnership with ADOT, retained design consultant NFra to develop the final construction plans, specifications, and estimates for the project. Two public meetings were be held October 24<sup>th</sup>, 2022 to receive feedback on the preliminary 15% design alternatives. Following the feedback received, the design has been revised and is now ready to be presented to solicit additional feedback on at two upcoming public meetings:

- Mon., April 17 at noon.
   Virtually via Zoom, tempe.gov/grandcanal
- Mon., April 17 at 5:30p.
   In-person at Field Services Assembly Hall located at 55 S. Priest Dr, Tempe.

It is anticipated that the final design will be completed Spring 2024, with construction beginning Fall 2024.
