

**ACTION:** Request approval to abate public nuisance items at the Gutierrez Property located 2109 E. Pegasus Drive. The applicant is the City of Tempe – Code Compliance.

FISCAL IMPACT: \$6366 for abatement request: remove trash, litter, debris & stored items from back yard.

**RECOMMENDATION**: Staff – Approval of 180-day open abatement

**BACKGROUND INFORMATION:** City of Tempe – Code Compliance Section requests approval to abate items in violation of the Tempe City Code at the GUTIERREZ PROPERTY. The details of this case represent several months of correspondence for compliance with the property owner. Staff requests the approval of abatement of the following nuisance items under Complaint CE222771: remove trash, litter, debris & stored items from back yard.

#### **COMMENTS:**

Code Compliance is requesting approval to abate the Gutierrez Property located at 2109 E. Pegasus Drive, in the R1-7 Single Family Residential district. This case was initiated 05/03/2022, after which Code Compliance has attempted to obtain compliance through correspondence with the property owner regarding violations of the Tempe City Code.

Without the intervention of abatement, the property will continue to deteriorate. It is therefore requested that the City of Tempe Community Development Hearing Officer approve a 180-day open abatement of this public nuisance in accordance with Section 21-53 of the Tempe City Code.

#### **FINDINGS:**

05/03/22 - A complaint was filed with the city of Tempe for junk, trash and debris in the front & side yards at 2109 E. Pegasus Drive. On 5/4/23 at 2109 E. Pegasus Drive in Tempe I observed furniture, wood, trash bags and miscellaneous household items in the driveway, front & side yards. Notice of Violation was sent to the owner of the property, For the 3 Cs Trust/Jesika Gutierrez, with a re-inspection date of 5/23/22.

06/14/22 — The owner had emailed me asking for an extension to June 13th. On June 14th the property was inspected to find slight improvement in the observable areas of the front & side yards. An additional complaint to the city for junk, trash and debris in the back yard had been received. I inspected the back yard and observed substantial stored items piled up throughout the yard. A second First Correction Notice was sent to Ms. Gutierrez to include the front, side and back yards with a re-inspection date of 7/18.

07/19/22 –The property was inspected and the front yard remaining items were yard-related and OK. The back yard continued to be filled with junk, trash, debris and stored items. Final notice was sent with a reinspection date of 8/15.

08/17/22 – The back yard of the property was re-inspected and found to have increased amounts of junk, trash, debris and stored items. A roll-off was observed in the carport so the owner was contacted via email to see what her plans were with regards to the back yard. The owner responded on August 19th saying she was working to address the back yard cleanup.

08/24/22 – I emailed the owner and gave her an extension to 10/3 and sent her a Heart Program brochure.

10/03/22 – The back yard was re-inspected and I observed that it continued to be full of junk/trash/debris and stored items. Photos were taken and citation #1702161 was issued.

11/16/22 – A court hearing was held for the first citation and the defendant was found responsible.

11/29/22 – I inspected the back yard and observed that it continued to be full of junk/trash/debris and stored items. Photos were taken and citation #1702162 was issued.

03/28/23 – The property was inspected with no change to its condition. Code Compliance filed for an Abatement Hearing. Notice was posted to the property.

### **RECOMMENDATIONS:**

I recommend the approval of a 180-day open abatement period for removal of junk, trash, debris and

stored items from 2109 E. Pegasus Drive, which is owned by For the 3 Cs Trust / Jesika Gutierrez. The owner has been given ample time and opportunities to bring this property into compliance and has failed to take any corrective action.

As owner of the property, you have thirty (30) days after receipt of this letter to abate or correct any violation as described below. If the violation(s) have not been corrected, our office will proceed with the abatement process.

Please remove the junk, trash, debris and all stored items in the back yard.

Upon receipt of the Hearing Officer approval to abate this public nuisance, the necessary work will be performed at the expense of the property owner. The cost of this work will be \$6366.00. In addition to the actual cost of abatement, an administrative charge of fifteen percent (15%) of the actual cost of abatement or three hundred (\$300) dollars, whichever is greater, for expenses incurred by the city for abatement procedures, and the cost of recording liens and releases will be charged. The recorded lien may bear interest at the legal rate of judgments in the State of Arizona. Administrative charges and the cost of recording liens and releases shall become a lien on the property whether or not the public nuisance is abated by the City.




