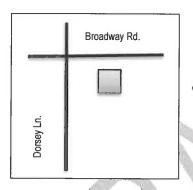

<u>ACTION</u>: Request approval to abate public nuisance items at the McCooey Property located 1430 E. Palmdale Drive. The applicant is the City of Tempe – Code Compliance.

FISCAL IMPACT: \$2066 for abatement request: front & back yard landscape cleanup.

**RECOMMENDATION:** Staff – Approval of 180-day open abatement

**BACKGROUND INFORMATION:** City of Tempe – Code Compliance Section requests approval to abate items in violation of the Tempe City Code at the MCCOOEY PROPERTY. The details of this case represent several months of correspondence for compliance with the property owner. Staff requests the approval of abatement of the following nuisance items under Complaint CE232224: front & back yard landscape cleanup.

#### **COMMENTS:**

Code Compliance is requesting approval to abate the McCooey Property located at 1430 E. Palmdale Drive, in the R1-6 Single Family Residential District. This case was initiated 4/13/23 after which Code Compliance has attempted to obtain compliance through correspondence with the property owner regarding violations of the Tempe City Code.

Without the intervention of abatement, the property will continue to deteriorate. It is therefore requested that the City of Tempe Community Development Hearing Officer approve a 180-day open abatement of this public nuisance in accordance with Section 21-53 of the Tempe City Code.

### **FINDINGS:**

4/13/2023 This inspector identified the property in violation of having Grass and Weeds in the front gravel landscape. Correction notice mailed.

4/27/2023 Inspected property, no progress made, Mailed Final Notice to property owner.

5/11/2023 Inspected property, violations present, left red tag with contact information and instructions to contact this inspector by 5/15/23 to avoid citation on 5/16/23.

5/16/2023 Issued citation #1789701 for grass and weeds and weeds in gravel landscape.

5/30/2023 Property inspected, still in violation.

6/6/2023 Property inspected, violations still exist, including backyard over height grass and weeds. Photos taken, send notice for backyard over height grass and weeds.

6/13/2023 Citation sent by certified mail, on 5/16/2023, was returned on 6/13/23 as Unclaimed, Unable to forward.

6/13/2023 Called cell number from water bill, 805-443-0157, at 3:00pm, for Kevin McCooey, no answer, left V/M to return call and discuss violations on property.

6/14/2023 Home contact attempt, no answer, posted citation on property door.

6/16/2023 Inspected property, violations exist in front and back of the property. Photos taken to show condition of the property. Submitting notice to abate. Mailed notice to abate to property owner and posted notice on property door.

#### **RECOMMENDATIONS:**

I recommend an abatement of the nuisance violations at the property at 1430 E Palmdale Dr due to property owner's failure to bring property into compliance with Tempe City Code 21-3.B.8. Mr. McCooey has been given ample time to come into compliance and maintain the property. The property owner has been issued a civil citation and has failed to appear to court. There has been no indication that the property owner will bring the property into compliance. The property represents a health hazard and an eyesore to the community.

Without the intervention of abatement, the property will continue to deteriorate. I therefore make a request to the City of Tempe Community Development Hearing Officer for authorization to abate this public nuisance in accordance with section 21-53 of the Tempe City Code and authorization of multiple abatements for a period not to exceed one hundred eighty (180) days from the previous abatement order.

clear of any uncontrolled growth regardless of height.

Please cut all over height weeds and grass from the backyard of the property.

Upon receipt of the Hearing Officer approval to abate this public nuisance, the necessary work will be performed at the expense of the property owner. The cost of this work will be \$2,066.00. In addition to the actual cost of abatement, an administrative charge of fifteen percent (15%) of the actual cost of abatement or three hundred (\$300) dollars, whichever is greater, for expenses incurred by the city for abatement procedures, and the cost of recording liens and releases will be charged. The recorded lien may bear interest at the legal rate of judgments in the State of Arizona. Administrative charges and the cost of recording liens and releases shall become a lien on the property whether or not the public nuisance is abated by the City.

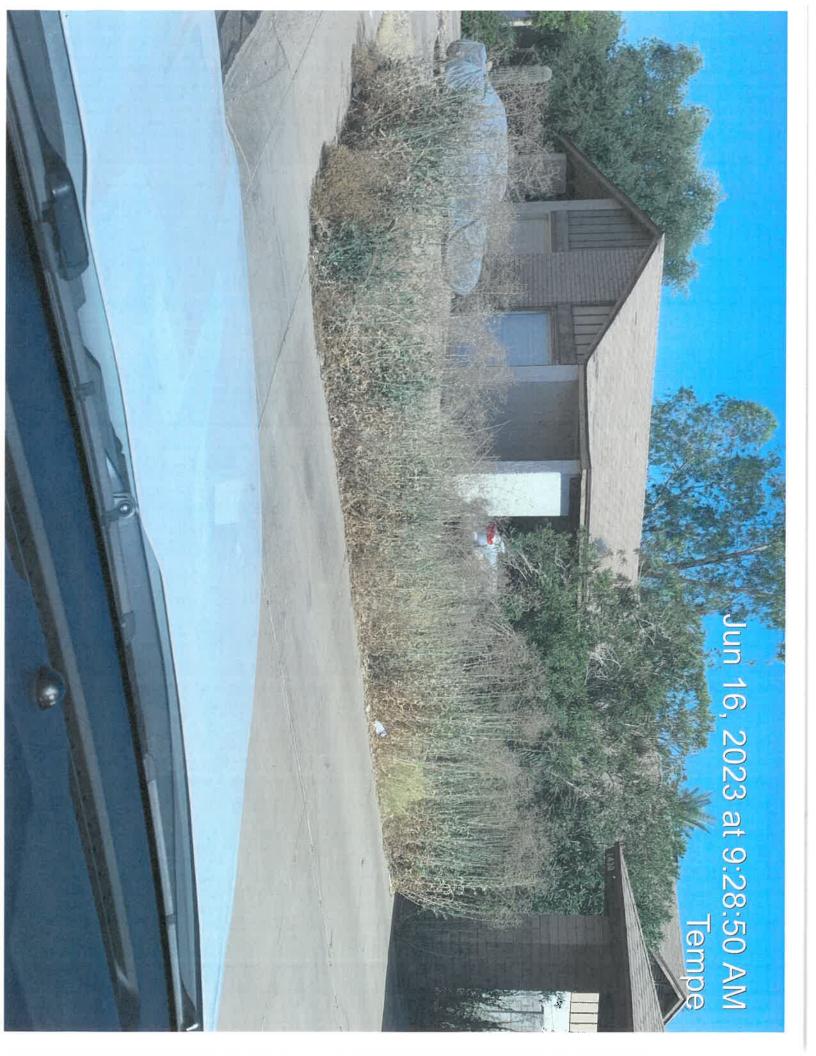

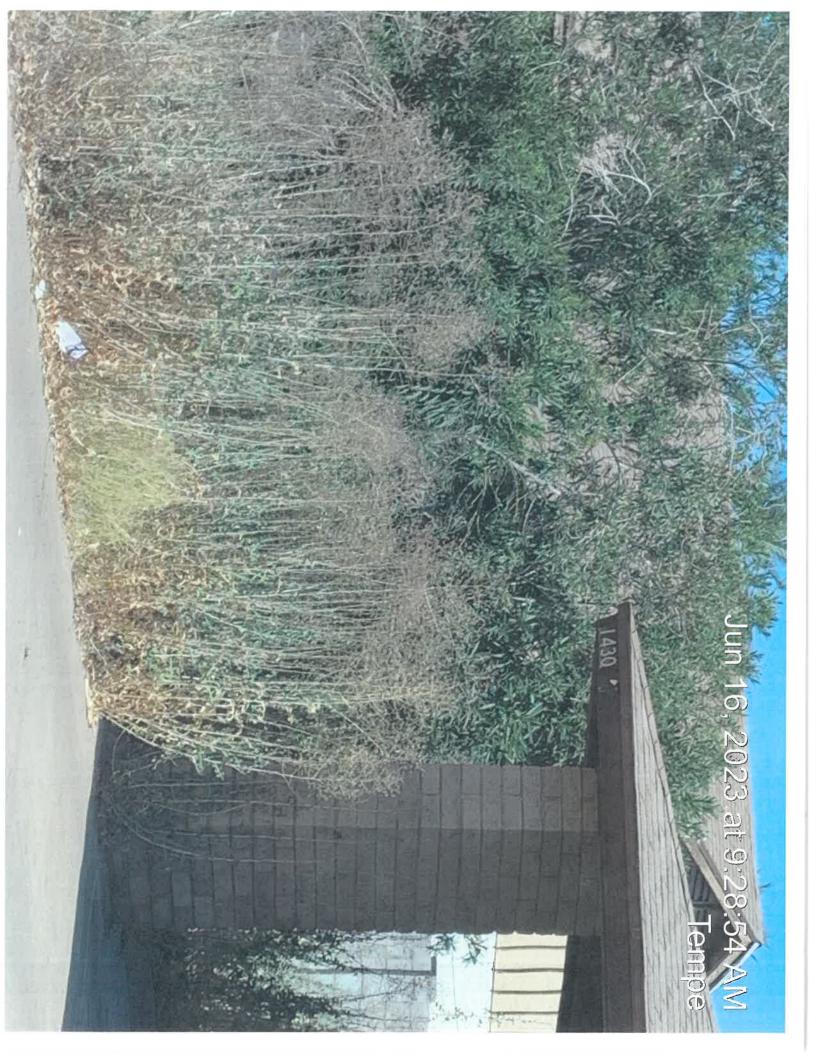

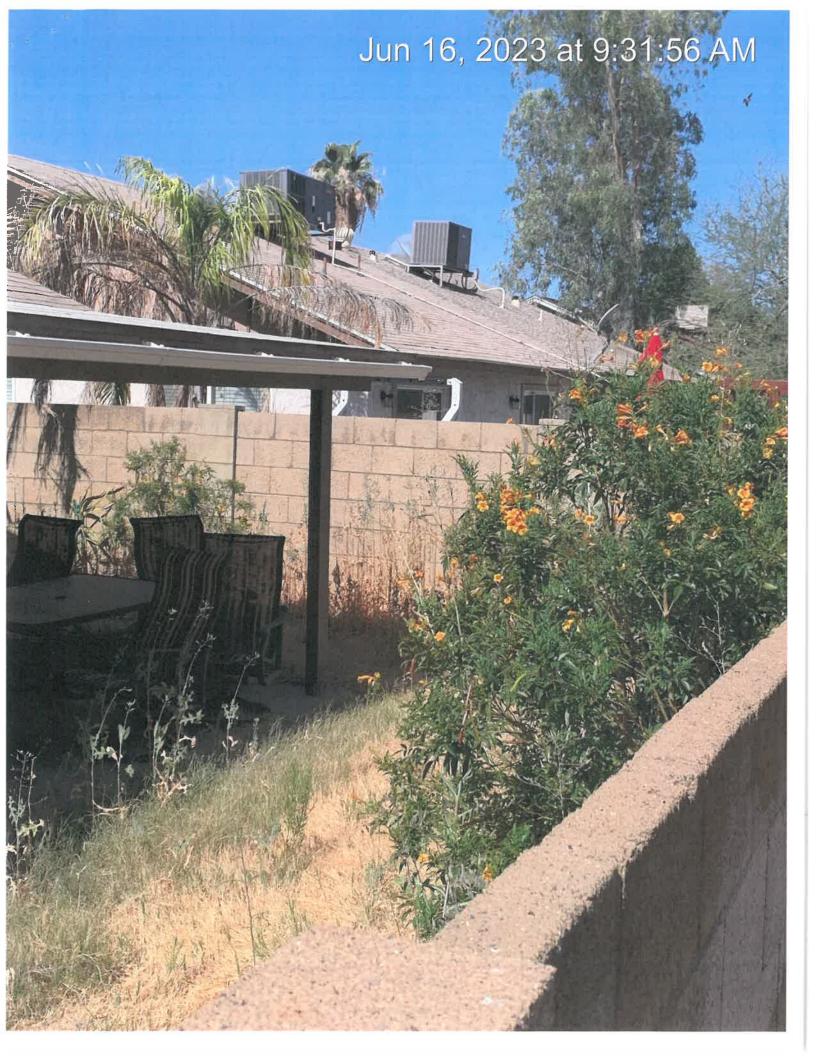
