

ACTION: Request approval to abate public nuisance items at the Flores Revocable Living Trust located 2413 W. Dunbar Dr The applicant is the City of Tempe – Code Compliance.

FISCAL IMPACT: \$918.00 for abatement request: Remove high grass and weeds, remove inoperable/unregistered vehicles.

RECOMMENDATION: Staff – Approval of 180-day open abatement

BACKGROUND INFORMATION: City of Tempe – Code Compliance Section requests approval to abate items in violation of the Tempe City Code at the FLORES REVOCABLE LIVING TRUST. The details of this case represent several months of correspondence for compliance with the property owner. Staff requests the approval of abatement of the following nuisance items under Complaint CE231333: Remove grass and weeds and inoperable/unregistered vehicles

COMMENTS:

Code Compliance is requesting approval to abate the Flores Revocable Living Trust Property located 2413 W. Dunbar Dr in the R1-6 Single Family Residential District. This case was initiated 10/17/22, after which Code Compliance has attempted to obtain compliance through correspondence with the property owner regarding violations of the Tempe City Code.

Without the intervention of abatement, the property will continue to deteriorate. It is therefore requested that the City of Tempe Community Development Hearing Officer approve a 180-day open abatement of this public nuisance in accordance with Section 21-53 of the Tempe City Code.

FINDINGS:

03.08.23: Code Compliance received anonymous complaints regarding a deteriorated landscape with over height through the front yard graveled areas including an inoperable / unregistered vehicle on the driveway. These concerns were verified, and a first notice was mailed to the property owner and tenants.

03.17.23 : Anonymous complaints were received regarding the deteriorated state of the property.

03.22.23 : Addition anonymous complaints were received regarding the deteriorating state of the property.

04.07.23 : An extension was granted to try to avoid any citations while progress could be accomplished.

04.17.23: Another extension was granted after the property owner was hospitalized due to ongoing health concerns. This message was delivered by a Neighbor Friend.

05.02.23 : A first citation was issued after the property was not brought into compliance. This citation then defaulted after a 14-day appeal period, which was not contested.

06.08.23 : A second citation was issued after the property was not brought into compliance. This citation then defaulted after a 14-day appeal period, which was not contested.

09.01.23: After multiple failed attempts to reach the property owner and citations the abatement packet was turned in for the October 03rd, 2023, Hearing Officer.

RECOMMENDATIONS:

I recommend an abatement of the nuisance violations at the property located at 2413 W DUNBAR DR TEMPE; AZ 85282 due to property owner's failure to bring property into compliance with Tempe City Code CC 21-3.B.3 & CC 21-3.B.8. JOE I FLORES REVOCABLE LIVING TRUST: JOE I FLORES TR has been given ample time to come into compliance and maintain the property. The property owner has been issued a civil citation and has failed to appear to court. There has been no indication that the property owner will bring the property into compliance. The property represents a health hazard and an eyesore to the community.

Without the intervention of abatement, the property will continue to deteriorate. I therefore make a request to the City of Tempe Community Development Hearing Officer for authorization to abate this public nuisance in accordance with section 21-53 of the Tempe City Code and authorization of multiple abatements for a period not to exceed one hundred eighty (180) days from the previous abatement order.

This serves as notification of the City of Tempe's intentions regarding the abatement of code violations on the following described property:

LOCATION: 2413 W DUNBAR DR TEMPE, AZ 85282

This office will submit this complaint to the Community Development Abatement Hearing Officer located at the Tempe City Council Chambers on 10.03.2023. We are requesting Hearing Officer Authorization to abate this public nuisance in accordance with Section 21-53 of the Tempe City Code by removal and repair of:

Violation of City of Tempe Codes

CC 21-3.b.3

• Any inoperable or unregistered vehicle, or parts thereof, outside of or under a roof area not enclosed by walls, doors, or windows of any building on any lot, except the safe and neat keeping of: A. Substantially complete inoperable or unregistered vehicles with inflated tires under the roof area of any building: B. A vehicle undergoing repair, titled to the owner or resident of the property, provided that the repair is complete within fourteen (14) days after the repair was begun, provided that not more than three (3) such fourteen (14) day repairs will be permitted in any twelve (12) month period.

CC 21-3.B.8

Any landscaping, visible from public property, that is substantially dead, damaged, or characterized by
uncontrolled growth, or presents a deteriorated or slum-like appearance; uncultivated plants, weeds, tall grass,
uncultivated shrubs or growth (whether growing or otherwise) higher than twelve (12) inches; or any dead trees,
bushes, shrubs or portions thereof, including stumps; or any palm or similar type tree having dead or dry fronds
descending downward from the base of the lowest living frond more than eight (8) feet or dry fronds longer than
five (5) feet and closer than eight (8) feet to the ground.

If the violations have not been corrected within thirty days, our office will proceed with the abatement process. As owner of the property, you have thirty (30) days after receipt of this letter to abate or correct any violation as described below:

- 1. Properly restore, repair, and register your vehicle or relocate to a more discreet parking location
- 2. Remove all over height grass / weeds from the property's front yard graveled areas permanently.

Upon receipt of the Hearing Officer approval to abate this public nuisance, the necessary work will be performed at the expense of the property owner. The cost of this work will be \$918.00. In addition to the actual cost of abatement, an administrative charge of fifteen (15) percent of the actual cost of abatement or three hundred (\$300) dollars, whichever is greater, for expenses incurred by the city for abatement procedures, and the cost of recording liens and releases will be charged. The recorded lien may bear interest at the legal rate for judgments in the State of Arizona. Administrative charges and the cost of recording liens and releases shall become a lien on the property whether or not the public nuisance is abated by the City.
