### 1. Agenda Item No. 1

### September 3, 2024 Hearing Officer Minutes

**Vanessa MacDonald**, Hearing Officer, stated that the September 3, 2024 Hearing Officer Minutes had been reviewed and were approved.

#### 2. Agenda Item No. 2

Request approval to abate public nuisance items at the ARVAYO Property located at 1122 S. Holbrook Lane. The applicant is the City of Tempe (CE234894).

- Andres Lara-Reyes, Code Inspector, gave the following overview of this case:
  - o Inspector Lara-Reyes requested a 180-day open abatement for 1122 S. Holbrook Lane.
  - The case was initiated on 9/5/23 for trash & debris, inoperable vehicles and over height grass and weeds in the front and rear yards.
  - Two (2) citations were also issued. The property owner did pay the fees, but the violations were still on the property.
  - The inspector then presented photos taken earlier in the day showcasing the violations on site.
  - The property owner, Eliberto Arvayo stated that he is making progress on cleaning up the property but still needs more time.
- Drew Yocom stated no contact has been made by the any other member of the public to speak on behalf of this case
- Hearing Officer MacDonald approved the 180-day open abatement request found in CE234894.

## 3. Agenda Item No. 3

Request abatement of public nuisance items at the **BLACKSTAD PROPERTY** located at 2119 E. Sesame Street. The applicant is the City of Tempe (**CE241852**).

- Hector Heredia, Code Inspector, gave the following overview of this case:
  - o Inspector Heredia requested a 180-day open abatement for 2119 E. Sesame St.
  - The case was initiated on 3/13/24 for junk/debris, deteriorating landscape in the front and rear yards, and a green swimming pool.
  - Numerous complaints have been submitted to Code Compliance.
  - Two (2) citations were also issued. The property owner did not pay the fee and it was sent to collections.
  - o The inspector then presented photos taken earlier in the day showcasing the violations on site.
- Drew Yocom stated no contact has been made by the property owner or any other member of the public to speak on behalf of this case.
- Hearing Officer MacDonald approved the 180-day open abatement request found in CE241852.
