- **Garilyn Bourgeois** gave a presentation about the Arts & Culture Division's marketing mission, strategies, priorities, and deliverables.
- Commissioner feedback
 - Would like to see the collection of Key Performance Indicators for data outside of just paid events, such as free events, gauging engagement of underserved communities, successful use of alternative spaces, frequency of attendance to A+C events, etc.
 - O Don't want to lose sight of offering free programs and events to the community.
 - o Is it possible to assist resident companies with more PR/Marketing to bring in more attendees?
 - Would like marketing to push out recommendations for events based on what an attendee has already chosen.
 - O Please make it easier to share announcements and events on social media (click-click-post).
 - HOAs and Neighborhood Associations could be utilized to disseminate information about local Arts + Culture events.
 - Southwest Contemporary publication (like a southwest version of Hyper Allergic) covers Tempe events.

 - Tempe History Museum 33 volunteers
 - O Community Arts 10 volunteers
