- Maja Aurora presented IN FLUX artist Pete Goldlust’s work. “Cycle Ops”, Discussion highlights included:
 - Pete Goldlust was selected to create an installation for the vacant storefront windows at the Tempe Transportation Center, 200 E. Fifth St. Tempe, 85281.

- Laura Hales and Kyllan Maney reported about progress of the New School for the Arts and Academics’ Arts Project Grant. Discussion highlights include:
 - “Visions”, a Scottsdale Museum of Contemporary Art program, is designed to encourage creative self-expression and civic engagement. NSAA high school art students meet monthly with artists for workshops, gallery talks and studio visits.
 - The resulting artwork is shown in an annual summer exhibition opening on May 9th, 5pm, Scottsdale Center for the Performing Arts’ young@art gallery
- Dick Bowers reported about the status of the Phoenix Boys Choir’s Arts Project Grant. Discussion highlights included:
 - Founded in 1947, the PBC has programs featuring training in voice, music theory, and performance for boys age 7 to 14. <http://www.boyschoir.org/>
 - PBC has modified their project grant and will offer a summer training outreach program for boys and girls will be held at Fees College Preparatory Middle School. The goal is to reopen the Tempe Training Choir location next school year.
