**SUBJECT:** Commission Resident Member

**COMMENTS:** Staff will share progress on securing a resident representative to the Enhanced Services Commission.

The position of the third non-voting member, a resident of the district, does not appear to require the Mayor's appointment. Section 7, Vacancies, states that other than the ASU member, Public member and City member, any vacancy is filled by the Board of Directors. As the Mayor doesn't make the appointment, the City Clerk's Office has indicated that they don't need to be involved in the process.

The Rio Salado Enhanced Services Commission organized as a 501(C) (3), and approved bylaws, thus, the requirements are a little different from the City's typical board/commission process.

An application form was created for your review. Once the application form is approved it's to be distributed to the homeowners association managers for Edgewater, Bridgeview and Northshore condominiums. There will be a 30 to 45 day period for applicants to respond. Contacts for these HOA's are listed below.

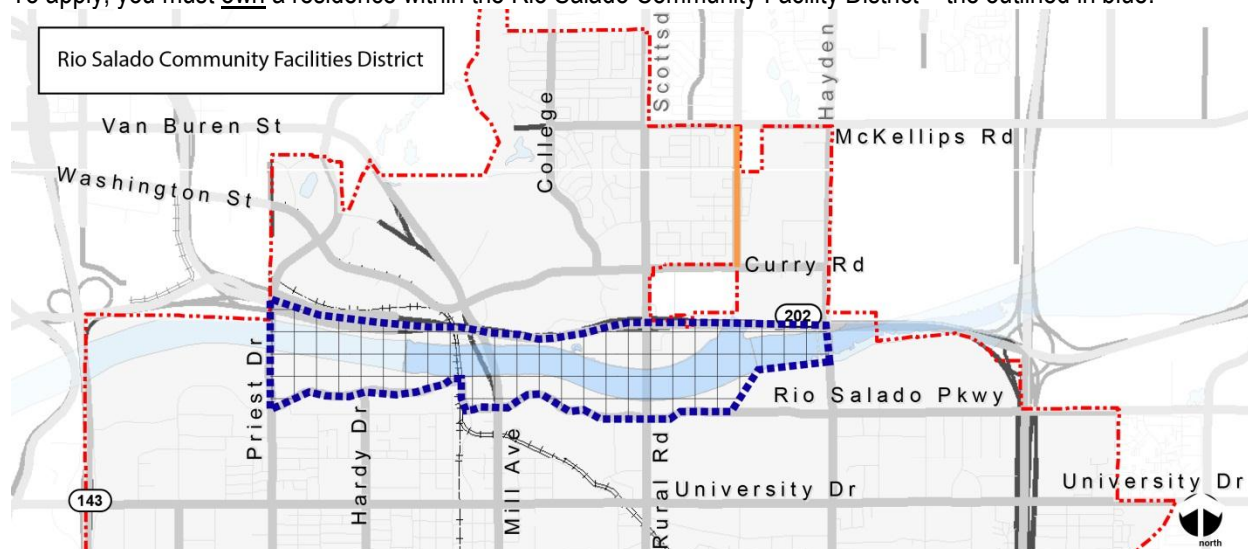
### RESIDENTIAL AT-LARGE REPRESENTATIVE

The Enhanced Services Commission is a representative association for Tempe Town Lake property owners, created by the City of Tempe in 1999 as a 501(c)(3) corporation for the purpose of serving in an advisory capacity to the City of Tempe and the Rio Salado Community Facilities District governing board (Tempe City Council).

The Enhanced Services Commission has the following powers and duties:

- To review and approve the official minutes of all meetings of the Enhanced Services Commission as prepared by the Secretary.
- To advise and make recommendations to the governing board of the District (Tempe City Council) regarding the Annual operations and Maintenance Budget and the Capital Budget.
- To advise and make recommendations to the governing board of the District (Tempe City Council) regarding all policy decisions having potential significant impact on the Annual Operations and Maintenance Budget specifically including but not limited to any budget line item which equals a ten percent (10%) or greater change over the same line item from a previous budget and any increase in the overall budget of five percent (5%) or greater.
- To advise and make recommendations to the governing board of the District (Tempe City Council) regarding the quality of public and private services, general policies for the programming of events within the District and general policies of lake use and lakeshore park use.

To apply, you must own a residence within the Rio Salado Community Facility District – the outlined in blue.
