### Agenda Item 3 – Speak Out PR Campaign – Ginny Belousek

Ginny Belousek gave an update to the Commission regarding the PR Campaign poster. Ginny met with the City's Public Information Officer, Clerk, and Director of Strategic Management & Diversity where it was indicated that the role of the commission is to advise the City Council. The commission's poster would represent a value statement and is therefore larger than the HRC. The City currently incorporates inclusion in all aspects of its brands and statements. Ginny recommended that the commission consider a press release to help promote the commission to the public. Ginny also recommended bringing back a community forum that the commission used to host, Community Conversations.

Discussion was held on whether the commission should proceed with the PR Campaign poster or look for other avenues to get their message out. Due to current national events, the commission decided to move forward with the PR Campaign initiative as a message and not limit the media at this point. The commission agreed upon a letter to City Council advising them to get the HRC's message out that all are welcome in Tempe.

MOTION made by Commissioner Castelli for Chair Hermanns to draft, and send, a letter to City Council and then to meet with a City Council Member to discuss advocacy and process. Letter is to be accompanied with a message proposal.

Commissioner Castelli left the meeting at 7:03pm. This caused the meeting to no longer have a quorum and the meeting was subsequently adjourned.
