

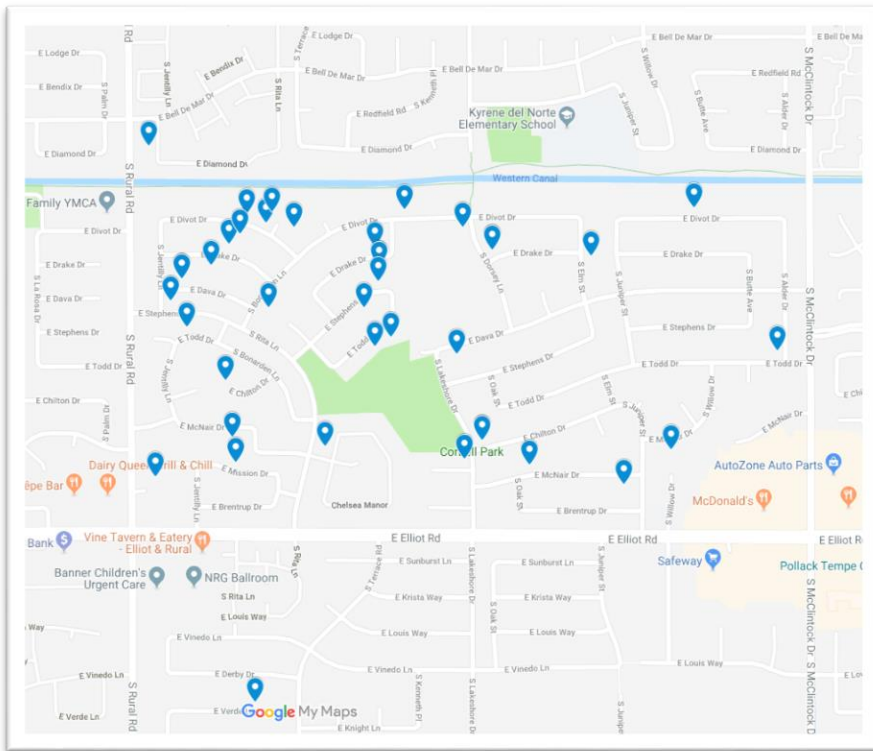


PUBLIC INPUT SUMMARY

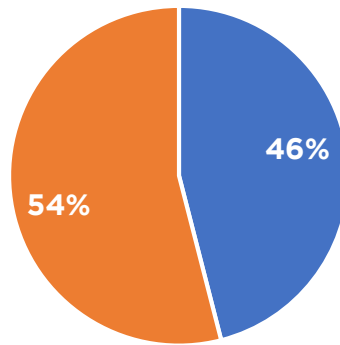
Overview

A public meeting was held on November 17, 2018 for feedback on planned improvements for Corbell Park. Residents in the area of the Western Canal to E Elliot Rd, the Kyrene Branch Canal to S. McClintock Dr. (1235 residents) were invited to participate in the process via postcard. Notices were posted to Nextdoor to 254 households directing residents to both the meeting and the website. Park signs were also placed in the park announcing the meeting. Fifteen (15) people signed in for the meeting in the park. Residents were asked to provide input on play structure design and equipment layout, shade location, ramada locations, ramada finish, color palette, and park hours. Surveys were available at the meetings and online from November 17, 2018 through December 1, 2018. A total of 40 survey responses were received; 10 at the meeting and 30 online, 2 from outside the project area.

Map of Survey Respondents

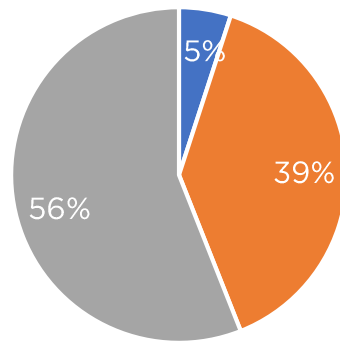


- Improvements to the playground will include picnic ramadas, a 5-12 play structure, shade, lighting, accessible sidewalks and additional trees. In addition, residents chose a modern playground design with a 2-5 play structure, arch swings, a net climber, fitness stations, and a sway bridge. 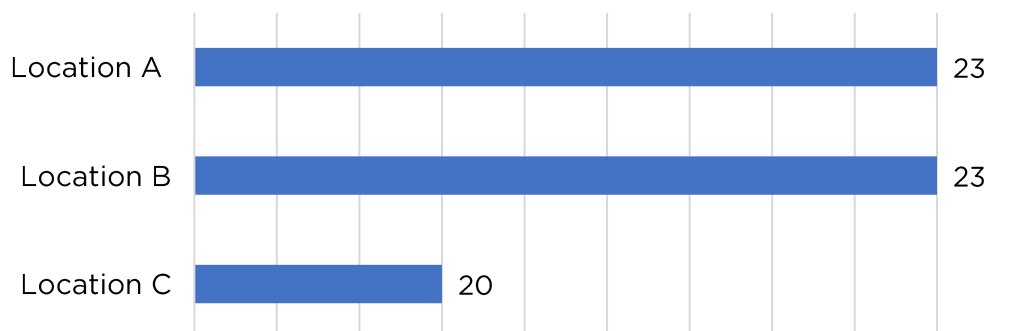
■ Playground Layout "B" (17) ■ Playground Layout "A"(20)

- One shade structure will be installed, where should it be placed?

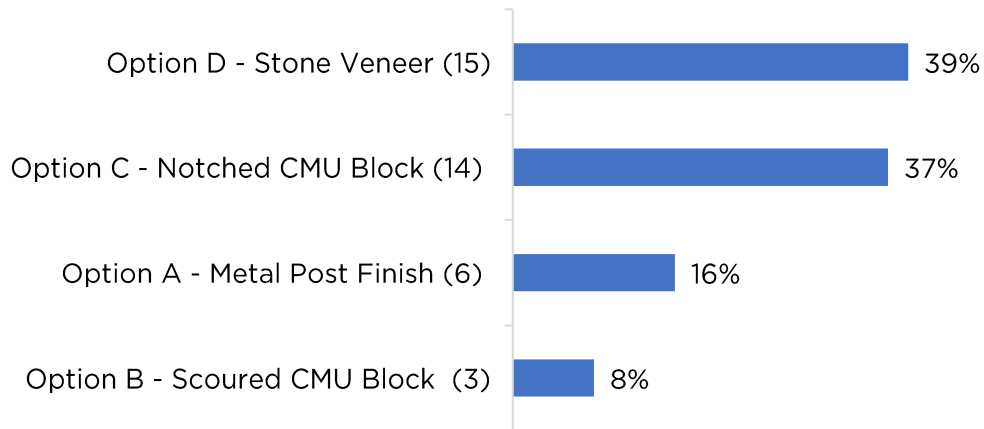


■ Over the swings (2) ■ Over the 2-5 Play Structure (14)
 ■ Over the 5-12 play structure (20)

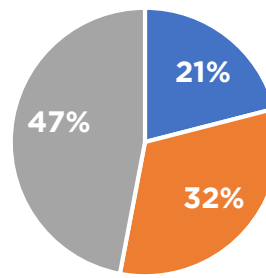

4. The picnic ramadas will have metal hip roofs. Which column material do you prefer?

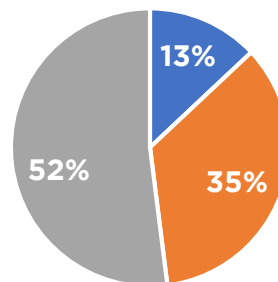


5. Which color palette do you prefer for the playground?

7. Additional Comments:

1. I've lived within walking distance to Corbell Park for over 17 years, and I'm so excited to see that it's *finally* getting some "TLC"!
2. Looks Good!
3. Let's apply for another shade structure!
4. It would be great to see the gravel path on the east side of the park paved. This would make walking in the park much better. Many people use the park for their morning walk. The gravel is often wet. A cement or even asphalt path would be wonderful. Love Corbell park. Very nice.
5. So pleased both options include the fitness station. Thanks so much for respecting the opinions of the people who use the park, and for such thoughtful planning. This is why we chose to live in Tempe!
6. We are very excited for these improvements!
7. I am tired of being the only one walking my dog consistently on a leash. I would appreciate it if you would put in a dog area for people to be able to take dogs off their leash to run free for a period of time. Even an area 20 feet by 40 feet would be nice to play with a dog off leash. I realize this is not a dog park but other people do not. I believe having a place for dogs is just as important as having a place for kids to play. A designated area to Allow dogs to run free for a period of time might keep the owners of dogs from allowing them to be off leash all over the park. Every day I walk my dog between 4:30 and 5:30 and there dogs off leash. The park needs to be better monitored, before someone gets bitten, AND give owners a place to let the dogs off leash to run around.
8. Shrinking the sports area (soccer field) by installing more trees along the east side of the field, seems like an undesirable idea.
9. All of the play areas should have shade structures. Money would be better spent on this instead adding 3 more Ramadas. The play structures get too hot without shade and become unusable for children or even dangerous as they can burn their skin during the summer when they need to use them the most.
10. All of the playgrounds should have shade structures to make them safe for all children. Playground structures get extremely hot during the summer months, precisely when the kids need them the most. Without shade they can burn children's skin or become unusable and thus are a waste of money. I think that shade structures should be priority even over additional ramadas as more people would benefit from them on a more frequent basis. If funds are too limited, instead of three more ramadas, install shade structures over every playground and swings and two ramadas and benches around the playgrounds would be sufficient. I would also recommend adding a couple of drinking fountains around the park and pathways inside the park for kids' tricycles, scooters, and bicycles.
11. We would love to see a bathroom put in the park somewhere. Happy to see playground upgrade, the current playground is pretty boring.
12. Will there be any grills at the park near ramadas?
13. All of the block finish options for the Ramada covers are nice, but they offer too many nooks for pigeons. Please make sure the new trees maximize shade for the existing benches along the north side of the park. I'd like to see the

park hours remain until midnight -or at least 11pm- to allow for several hours of quiet use/enjoyment into the evening during the hot summer months. (The noise ordinance would address any noise concerns.) Thank you for improving our parks. I also appreciate being able to respond online as I have been unable to attend the scheduled meetings.

14. It would be good to build tennis and volleyball courts
15. Our backyard opens onto the park. We are at the corner of Lakeshore and McNair. The mature shade tree that was planted on the north edge of the walking path immediately north and slightly west of our house, died and was cut down by the Parks department after it died. We would appreciate having the stump removed and a new tree planted where the space was created for the tree originally. I left a message for Craig about this today, Nov. 26, 2018. Thanks for your help. PS IF Parks Dept. can't remove the stump due to fiscal concerns, would it be possible for us to pay to get an estimate and pay (either Parks or someone else) to have it removed so that a new tree could be planted in the same place...or really close by?
16. More shade structures are needed over concrete sidewalks leading from the basketball court and sidewalk.
17. Please fix park sign.
18. Previous comments suggested the placement of more bag stations for dog waste- I agree, a couple more on the South side of the park would be beneficial.
19. I would highly prefer not having Ramada A and the associated pavement. The park is great as is mostly due to the lack of structure. Open green spaces are lacking in the city and if there is going to be more concrete and ramadas please leave them on the east side of the park so the entire west side can be a canvas for any recreational activities that just need space. Thank you!
