2018 International Fire Code Section 105.7 Required Construction Permits



Fire plan review times indicates the target number of **working days** to complete the first review. Turnaround times can fluctuate based on the workload and complexity of the project. The review times listed assume complete and clear plan submittals. The administrative review is included in the initial review time.
