Agenda Item 4 – Friends of the Tempe Public Library Report:

- Larry Conway presented the following information.
 - Camera's will be installed in the Connections Café.
 - For potential legal purposes.
 - Will offer a way to review if there are any problems in the Café.
 - Summer classes will be held June 3 to June 27.
 - Financials are where they are expected to be at this time of year.
 - The Friends of the Tempe Public Library are preparing to upgrade and refresh their website, social media, and brochures.
 - Chris Sar asked if there was a specific incident that prompted the need for cameras.
 - Larry replied that was not one specific instance but there has been a need for them in the past to address behaviors.

Agenda Item 5 – Staff Report:

- Kathy Husser presented the following update.
 - 11 no trespassing signs were installed last month around the Library campus.
 - The annual volunteer luncheon was held on April 9.
 - A presentation was made to the Friends for donating money to replace computers in the Youth Library.
 - Institute of Museum and Library Sciences (IMLS) award nomination.
 - Banners up in the plaza for two weeks.
 - The State Librarian and Secretary of State visited the Library and filmed a video for Facebook Live with staff.
 - The Library hosted its annual Writing Contest on April 10.
 - The Friends provided the cash awards to the winners.
 - There were 88 attendees.
 - Fifth year of the writing contest magazine.
 - The second Annual Seed Library Celebration took place on April 13.
 - 50 attendees to the event.
 - To date the Library has checked out about 4000 seed packets.
 - The Summer Reading Program begins on June 1.
 - The theme will be A Universe of Stories.
 - The Library's next StoryWalk book will tie into the space theme with "A Moon of My Own."
 - The book has been read on the International Space Station (ISS).
 - The Communico software purchase and implementation is moving forward.
 - Recruitments for several positions are underway.
 - May 13 through August 15 Mill Ave will be closed between University Drive and Rio Salado for street car construction.

- City employees are being encouraged to park at the Library and ride the Orbit to downtown offices.
- The Tempe City Council Chambers will undergo a remodel starting on July 31.
 - City Council Chambers will transition to the Tempe History Museum during the remodel until completion on January 31.
- The Library's Water for Fines program will run June 3 to 23.
- Joaquin Rios asked if there are a lot of City offices impacted by the construction.
 - Kathy replied that businesses and pedestrian traffic will be the most affected.
