

DRAFT MINUTES HEARING OFFICER June 18, 2019

Minutes of the regular public hearing of the Hearing Officer, of the City of Tempe, which was held at the Council Chambers, 31 East Fifth Street, Tempe, Arizona.

Vanessa MacDonald, Hearing Officer, stated the May 7, 2019 Hearing Officer Minutes had been reviewed and were approved.

2. Request abatement of public nuisance items at the **ECKENRODE PROPERTY** located at 3245 S Kenwood Ln. The applicant is the City of Tempe (**CE191241**).

Michael Glab, Code Inspector, gave the following overview of this case:

- In February 2019, Code Compliance received a complaint for junk, debris, and trash, Inspector Glab sent notice to property owner.
- In March 2019, Inspector Glab returned to property, spoke with tenant, and mailed second notice to owner.
- In early April 2019, Inspector Glab returned to property, noticed little to no change. There he spoke to the tenant who asked for an extension, to which Glab granted until late April.
- In late April, there was no change, Ms. Eckenrode said mail was stolen to Inspector Glab in a voicemail exchange, Inspector Glab said he would forgo citing her.

Hearing Officer MacDonald asked for audience input and Ms. Sandra Eckenrode, spoke on behalf of her property:

- She stated she has cancer and did not go outside since November until late March.
- She stated the tenant, Charlie, stolen her mail therefore she never knew about the on-going abatement process.
- She believes Charlie is now a hoarder and he has special rights.

Hearing Officer MacDonald approved a 180-day abatement.

3. Request abatement of public nuisance items at the **SIVAK PROPERTY** located at 1969 E Palomino Dr. The applicant is the City of Tempe (**CE192215**).
