Commissioner Amorosi asked about sustainability regarding vegetation and who monitors this. He was advised that this would be monitored by Code Enforcement. Commissioner Sumners asked how transfers are tracked and was advised this would be through the City. Mr. Ryan Levesque, Deputy Director – Community Development, stated that an overlay by ordinance would do this.

Vice Chair DiDomenico inquired about the status of the renovation to the City Council chambers. He was advised that the second DRC meeting would be at that location, barring any delays as the opening of the Council Chambers is planned for February 13, 2020.
