- Why was the University Drive option removed early in the process since it showed as favorable (green) early on?
- How does ridership factor into the Rio Salado east option?
- Is streetcar really the best option for Rural Road?

- Can Tempe look at transit options to connect south Tempe to the rest of the downtown area and light rail?
- There's a lack of north/south connectivity
- Conversations need to be regional, appreciate the connection with Mesa.
- When could the project realistically be built and operational?
- There's construction fatigue.
