
Agenda Item: 3

**ACTION:** Request approval to abate public nuisance items at the O'Connor Property located at 6818 S. Terrace Road. The applicant is the City of Tempe – Code Compliance.

**FISCAL IMPACT:** \$701.00 for abatement request: removal of tall grass & weeds and boxes, trash and appliances from the front yard.

**RECOMMENDATION:** Staff – Approval of 180 day open abatement

**BACKGROUND INFORMATION:** City of Tempe – Code Compliance Section requests approval to abate items in violation of the Tempe City Code at the O'CONNOR PROPERTY. The details of this case represent several months of correspondence for compliance with the property owner. Staff requests the approval of abatement of the following nuisance items under Complaint CE197376: removal of tall grass & weeds and boxes, trash and appliances from the front yard.

#### **COMMENTS:**

Code Compliance is requesting approval to abate the O'Connor Property located at 6818 S. Terrace Road, in the R1-6, Single Family Residential district. This case was initiated 11/18/2019, after which Code Compliance has attempted to obtain compliance through correspondence with the property owner regarding violations of the Tempe City Code.

Without the intervention of abatement the property will continue to deteriorate. It is therefore requested that the City of Tempe Community Development Hearing Officer approve a 180 day open abatement of this public nuisance in accordance with Section 21-53 of the Tempe City Code.

#### FINDINGS:

11/18/19 - The Code Compliance Division received a complaint regarding junk and debris in the front and side yard.

11/26/19 - The property was inspected and found to have trash, appliances, and miscellaneous items in the front yard, side yard, and driveway. Due to repeat offense, final notice was mailed to Ms. O'Conner.

12/18/20 – The property was inspected and found to have more junk and debris and a new violation of over height weeds/grass. Sent a revised final notice adding the landscape violation.

01/09/20 – The property was inspected with no change. Sent an email to Bob Hamann requesting an abatement bid.

01/10/20 – Received a bid from Bob Hamann to cleanup the landscape and remove the junk and debris from the front and side yard for \$701.00

01/17/20 – The property was inspected and found no improvement to property violations. Code Compliance filed for Abatement with a hearing date of 2/18/20.

#### **RECOMMENDATIONS:**

I recommend the approval for abatement at 6818 S. Terrace Rd., which is owned Ms. Tamera O'Conner. Ms. O'Conner has been given ample time and opportunities to bring her property into compliance and has failed to take any corrective action. Since Ms. O'Conner is unable to maintain her property, I am requesting approval for continuous abatements in the next 180 days if deemed necessary. There has been no indication from Ms. O'Conner that she plans to correct and maintain her property.

This serves as notification of the City of Tempe's intentions regarding the abatement of code violations on the following described property:

This office will submit this complaint to the Abatement Hearing Officer to be placed on the Hearing Officer agenda of February 18, 2020. We are requesting Hearing Officer Authorization to abate this public nuisance in accordance with Section 21-53 of the Tempe City Code by removal and repair of: Those items constituting a violation of TCC 21-3-b-1, and TCC-21-3-b-8 which would include the following: landscape clean-up in the front and side yard, and removal of all junk in debris.

As owner of the property, you have thirty (30) days after receipt of this letter to abate or correct the violation. If the violations have not been corrected within thirty days, our office will proceed with the abatement process. Upon receipt of the Hearing Officer approval to abate this public nuisance, the necessary work will be performed at the expense of the property owner. The cost of this work will be \$\frac{701.00}{201.00}\$ In addition to the actual cost of abatement, an administrative charge of fifteen (15) percent of the actual cost of abatement or three hundred (\$300) dollars, whichever is greater, for expenses incurred by the city for abatement procedures, and the cost of recording liens and releases will be charged. The recorded lien may bear interest at the legal rate for judgments in the State of Arizona. Administrative charges and the cost of recording liens and releases shall become a lien on the property whether or not the public nuisance is abated by the City.

Any landscaping, visible from public property, that is substantially dead, damaged, or characterized by uncontrolled growth, or presents a deteriorated or slum-like appearance; uncultivated plants, weeds, tall grass, uncultivated shrubs or growth (whether growing or otherwise) higher than twelve (12) inches; or any dead trees, bushes, shrubs or portions thereof, including stumps; or any palm or similar type tree having dead or dry fronds descending downward from the base of the lowest living frond more than eight (8) feet or dry fronds longer than five (5) feet and closer than eight (8) feet to the ground.

# PLEASE TAKE THE FOLLOWING CORRECTIVE ACTION

- 1. Remove the boxes, trash, appliances, household and miscellaneous items from the front yard, side yard, and driveway.
- 2. Trim the over height weeds/grass in the front and side yard.
