<u>Agenda Item 4 - Overview and input into Operating Budget (Fiscal Year 2020/2021) and Capital (CIP) Budget FY 2020/21 thru FY 2024/25, Municipal Budget Director Mark Day</u>

Mark Day, who has served in the position of Municipal Budget Director for the past year, walked commission members through his Budget presentation. This presentation was included in the meeting packet materials and is the same one used for the three public Budget Forums. Mark listed the public involvement tools used to educate and encourage public participation in the process including the online budget tool, Tempe Today articles (water bill newsletter), three public forum meetings on different dates and times at three different locations, neighborhoods email list serve reminders, press releases, targeted postcards?, social media posts on facebook and nextdoor sites and solicited commission member input regarding the online Budget tool.

Staff inquired if commission members had tried out the tool, a link to the Budget page was forwarded to them in advance of the meeting with the Sunday, March 1 deadline noted. Commissioner Harden shared that she had tried out the tool and found it easy to use and that it makes you think. She then asked what Mark saw as the biggest funding gap?

Mark noted this is the same tool that City Council uses as an exercise and that like all budgets if you increase spending in one area, you need to cut back in another. He again emphasized the outreach which resulted in approximately 200 responses and shared his willingness to visit neighborhood or hoa meetings as a city budget guest speaker and/or asked how to further increase public awareness and participation whether online or at scheduled public meetings. Commissioner Stein remarked on the public's "civic knowledge gap" and Mark noted that the Budget tool had been publicized on the city website/Tempe forum? and remained open two to three months. Staff will verify timeframe.

In advance of the meeting, Mark had staff forward out two questions for commission members to think about after reviewing the budget presentation in the packet and perhaps trying out the budget tool.

- 1) What budget related information and resources would be useful to you as a commission member in performing your duties?
- 2) How do you think the City can improve on how it receives input from neighborhoods and residents on budget priorities?
