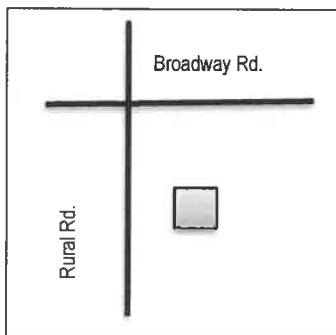

**ACTION:** Request approval to abate public nuisance items at the Wojciechowski Property located at 1034 E. Loma Vista Drive. The applicant is the City of Tempe – Code Compliance.

**FISCAL IMPACT:** \$486.00 for abatement request: Landscape cleanup.

**RECOMMENDATION:** Staff – Approval of 180 day open abatement

**COMMENTS:**

Code Compliance is requesting approval to abate the Wojciechowski Property located at 1034 E. Loma Vista Drive, in the R1-6, Single Family Residential district. This case was initiated 02/06/20, after which Code Compliance has attempted to obtain compliance through correspondence with the property owner regarding violations of the Tempe City Code.

Without the intervention of abatement the property will continue to deteriorate. It is therefore requested that the City of Tempe Community Development Hearing Officer approve a 180 day open abatement of this public nuisance in accordance with Section 21-53 of the Tempe City Code.

We are requesting Hearing Officer Authorization to abate this public nuisance in accordance with Section 21-53 of the Tempe City Code by removal and repair of:

If the violations have not been corrected within thirty (30) days, our office will proceed with the abatement process. As owner of the property, you have thirty (30) days after receipt of this letter to abate or correct any violation as described below:

**CC 21-3.b.8 Please remove the over height grass/weeds from the property (e.g. the east side of the driveway, etc.)**

Upon receipt of the Hearing Officer approval to abate this public nuisance, the necessary work will be performed at the expense of the property owner. The cost of this work will be \$486.00. In addition to the actual cost of abatement, an administrative charge of fifteen(15) percent of the actual cost of abatement or three hundred (\$300) dollars, whichever is greater, for expenses incurred by the City for abatement procedures, and the cost of recording liens and releases will be charged. The recorded lien may bear interest at the legal rate of judgments in the State of Arizona. Administrative charges and the cost of recording liens and releases shall become a lien on the property whether or not the public nuisance is abated by the City.
