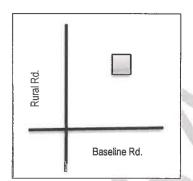
Agenda Item: 4

ACTION: Request approval to abate public nuisance items at the Mowahed-Ardbillie Property located at 1015 E. Frost Drive. The applicant is the City of Tempe – Code Compliance.

FISCAL IMPACT: \$927.00 for abatement request: removal of junk, trash and debris from front and sides of property, remove unregistered vehicle.

RECOMMENDATION: Staff – Approval of 180 day open abatement

BACKGROUND INFORMATION: City of Tempe – Code Compliance Section requests approval to abate items in violation of the Tempe City Code at the MOWAHED-ARDBILLIE PROPERTY. The details of this case represent several months of correspondence for compliance with the property owner. Staff requests the approval of abatement of the following nuisance items under Complaint CE205035: removal of junk, trash and debris from front and sides of property, remove unregistered vehicle.

COMMENTS:

Code Compliance is requesting approval to abate the Mowahed-Ardillie Property located at 1015 E. Frost Drive, in the R1-6, Single Family Residential district. This case was initiated 08/03/20, after which Code Compliance has attempted to obtain compliance through correspondence with the property owner regarding violations of the Tempe City Code.

Without the intervention of abatement the property will continue to deteriorate. It is therefore requested that the City of Tempe Community Development Hearing Officer approve a 180 day open abatement of this public nuisance in accordance with Section 21-53 of the Tempe City Code.

FINDINGS:

08/03/2020 The Code Compliance Division received a complaint for junk and debris. Inspected the property and found boxes and items stored in the porch area of the front of the property. Notice to comply was mailed to the owner.

08/21/2020 Re-inspected the property. There has been no change to the items stored in the front of the property. Also adding an unregistered vehicle parked in the driveway. A final notice was mailed to the owner.

09/09/2020 Inspected the property and there has been no change to the vehicle. Mailing a final notice for the vehicle and hung up a pink hanger on the door asking for contact or compliance.

09/29/2020 There has been no change in the storing of items or the registering of the vehicle. Citation # 1702241 was issued. Pictures were taken to reflect the violations at that time.

10/20/2020 Code compliance received a complaint for this property regarding junk, debris, and trash.

10/27/2020 Turning in the paperwork for an abatement hearing to be held on December 1st, 2020.

RECOMMENDATIONS:

I recommend an abatement of the nuisance violation at the property located at 1015 E. Frost Dr. The property owner has failed to bring the property into compliance with Tempe City Code 21-3. B.1 and 21-3-b-3. Ms. Mowahed-Ardbillie has been given ample time. The property represents an eyesore and health and safety issue to the community.

Without the intervention of abatement, the property will continue to deteriorate. I therefore make a request to the City of Tempe Community Development Hearing Officer for authorization to abate this public nuisance in accordance with section 21-53 of the Tempe City Code and authorization of multiple abatements for a period not to exceed one hundred eighty (180) days from the previous abatement order.

This office will submit this complaint to the Community Development Abatement Hearing Officer to be placed on the Hearing Officer agenda of 12/01/2020 located at the Tempe Council Chambers, 31 E 5th Street, at 5pm. We are requesting Hearing Officer Authorization to abate this public nuisance in accordance with Section 21-53 of the Tempe City Code by removal and repair of:

CC 21-3.b.1 Filthy, littered, debris or trash-covered exterior areas

CC 21-3.b.3 An unregistered vehicle outside of or under a roof area not enclosed

If the violations have not been corrected within thirty (30) days, our office will proceed with the abatement process. As owner of the property, you have thirty (30) days after receipt of this letter to abate or correct any violation as described below:

CC 21-3.b.1 Please remove trash, litter and debris from front and or sides of the property.

CC 21-3.b.3 Please register or remove vehicle from the front of the property.

Upon receipt of the Hearing Officer approval to abate this public nuisance, the necessary work will be performed at the expense of the property owner. The cost of this work will be \$927.00. In addition to the actual cost of abatement, an administrative charge of fifteen(15) percent of the actual cost of abatement or three hundred (\$300) dollars, whichever is greater, for expenses incurred by the City for abatement procedures, and the cost of recording liens and releases will be charged. The recorded lien may bear interest at the legal rate of judgments in the State of Arizona. Administrative charges and the cost of recording liens and releases shall become a lien on the property whether or not the public nuisance is abated by the City.

This subsection shall not be deemed to include items kept in covered bins or metal receptacles approved by the county health officer or this code or any other ordinance of the city.

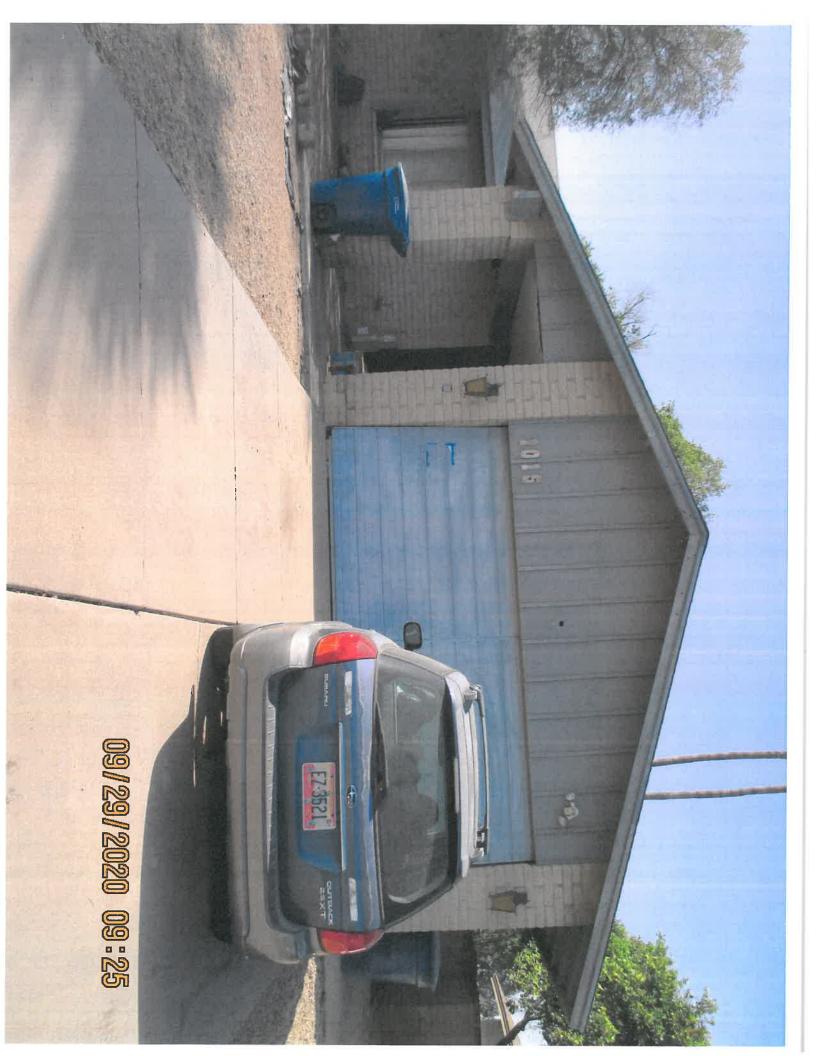

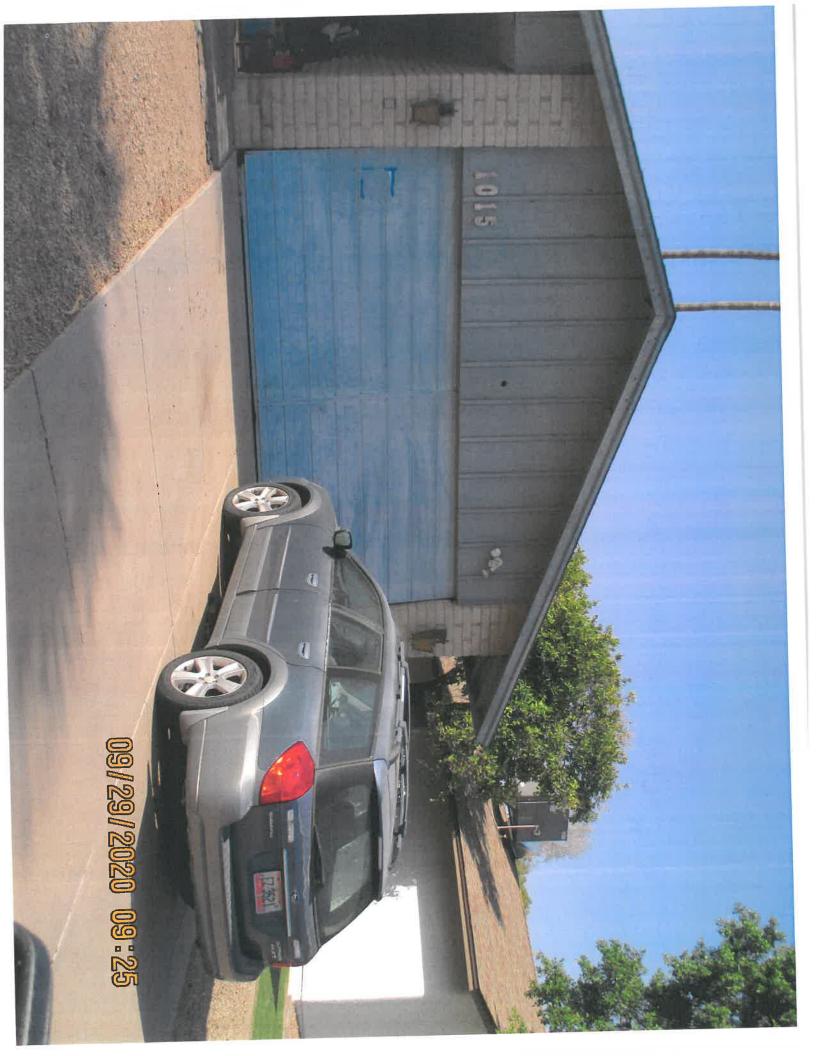
