SUBJECT: State Legislative Update and Background Information

State Legislative Update

As of this writing, we are over 140 days into the 2021 state legislative session. As of this writing, 1,730 bills have been posted, 409 have passed the Legislature, 381 have been signed by the Governor and 27 have been vetoed by the Governor.

State Budget

The week of 5/24/21, the House and the Senate introduced the state budget bills and heard them in their respective Appropriations Committees. However, the budget package did not have the votes to move forward beyond the committee level in either chamber. This is positive for cities, including Tempe, as the budget package included tax provisions harm cities. The tax provisions would result in an estimated annual revenue loss to Tempe of \$9.6 million when the tax is fully in effect. The cities continue to advocate for a solution that would hold municipalities harmless from revenue reductions at the state level. If the state reduces overall income tax revenue without increasing the proportion that flows back to cities to fund local needs, then cities' budgets across the state will be reduced.

Because of the lack of support for the budget in the House overall, the House adjourned until 6/10/21. The Senate then followed suit. Currently, we believe that the proposal will have to change in favor of cities in order to get sufficient support to pass. The state legislature is required to pass a budget prior to the end of the fiscal year (June 30^{th}).

In response to the budget stalemate, the Governor vetoed 22 bills, noting that he does not plan on signing any bills until the state budget is passed.

State Legislative Principles

At the November 5, 2020 Tempe City Council meeting, the Council reviewed and supported the 2021 State Legislative Principles. The principles are available at this link and continue to guide the development of policy statements and positions throughout the 2021 legislative session.

The First Regular Session of Arizona's 55th State Legislature began Monday, January 11, 2021. The State Legislature considers many legislative proposals throughout the session. Because of the broad responsibilities held by municipal governments, many legislative proposals have the potential to impact City operations, finances and governance.

The Tempe City Council has identified safety, strong community connections, quality of life, sustainability, and financial stability as priorities in the delivery of City services. The legislative principles reflect these strategic priorities and include topics that may be addressed during the 2021 session. The list is not exhaustive and staff seeks direction from the Mayor and Council on additional policy matters as they develop.

During the legislative session, staff works continuously with Mayor and Council, state legislators, the League of Arizona Cities and Towns and other partners to ensure that the City's perspective and interests are represented in policy discussions and decisions.

Arizona State Legislature Makeup and Tempe Legislators

Overall makeup of the State Legislature:

- House of Representatives: 31R-29D. This overall split is unchanged from the 2020 session, however, it is reflected in different districts—the Democrats lost one seat (LD-4) and the Republicans lost one seat (LD-20).
- State Senate: 16R-14D. This is a gain of one seat for the Democrats since last session (LD-28).

Tempe is overlapped by 3 legislative districts, LD 18, 26 and 27. Attached is a one-page document listing the senators and state representatives in these districts, including their contact information and committee assignments for the 2021 session.

Connect with Legislative Information

Weekly legislative updates are available through the City Council Weekly Information Packets. These packets are published evening Friday at this link. They contain updates from departments throughout the city and include state and federal updates. The hundreds of bills tracked by the city are included as a list with weekly updates on activity and the city's position. The bills are categorized by city department or focus area, e.g. "Strategic Management & Diversity", "Fire Medical Rescue", "Sustainability" and keyword searches can be done through the "Find" (Ctrl+F) feature.

Another way to connect is to sign up for the list-serve for legislative updates. These are typically "alerts" for fast-moving pieces of legislation which may have an upcoming decision that could warrant action prior to the City Council Weekly Information Packet publish date. To sign up, select "Elections and Legislative Alerts" (at the base of the list) at this link.
