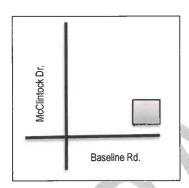

<u>ACTION</u>: Request approval to abate public nuisance items at the Harris Property located at 5005 S. Country Club Way. The applicant is the City of Tempe – Code Compliance.

FISCAL IMPACT: \$607 for abatement request: front and side yard landscape cleanup.

RECOMMENDATION: Staff – Approval of 180-day open abatement

<u>BACKGROUND INFORMATION</u>: City of Tempe – Code Compliance Section requests approval to abate items in violation of the Tempe City Code at the HARRIS PROPERTY. The details of this case represent several months of correspondence for compliance with the property owner. Staff requests the approval of abatement of the following nuisance items under Complaint CE216255: front and side yard landscape cleanup.

COMMENTS:

Code Compliance is requesting approval to abate the Harris Property located at 5005 S. Country Club Way, in the R1-6, Single Family Residential district. This case was initiated 10/04/2021, after which Code Compliance has attempted to obtain compliance through correspondence with the property owner regarding violations of the Tempe City Code.

Without the intervention of abatement the property will continue to deteriorate. It is therefore requested that the City of Tempe Community Development Hearing Officer approve a 180-day open abatement of this public nuisance in accordance with Section 21-53 of the Tempe City Code.

FINDINGS:

10/04/2021 The Code Compliance Division received a complaint for this property for deteriorated landscape. An inspection found that the property was in violation for grass and weeds in a gravel landscape, on the north side. A notice was mailed to the owner, Christopher Harris.

10/19/2021 There has been no change to the property. A final notice was mailed.

11/04/2021 There has been no change to the landscape. A pink hanger was placed on the door asking for contact or compliance by 11/08/2021 to avoid a citation.

11/09/2021 Received a call from Raquel, who says she is a roommate. She wanted to know what the issue was and what needed to be done to come into compliance. I called and left her a detailed message about the landscape.

11/18/2021 Issued a citation to the property owner for the deteriorated landscape. Citation # 1702431. Pictures were taken to show the condition of the property.

12/16/2021 There has been no change to the property. Requesting bids to conduct an abatement hearing.

01/04/2022 Turning in the abatement packet for the hearing to be heard on February 1st, 2022, for the landscape violation. The citation has gone to collections.

RECOMMENDATIONS:

I recommend an abatement of the nuisance violation at the property located at 5005 S. Country Club Way, due to property owner's failure to bring property into compliance with Tempe City Code 21-3. b.8. Mr. Harris was issued multiple notices. A citation was issued but has gone to collections. There has been no indication that the property

owner will bring the property into compliance. The property represents an eyesore to the community.

Without the intervention of abatement, the property will continue to deteriorate. I therefore make a request to the City of Tempe Community Development Hearing Officer for authorization to abate this public nuisance in accordance with section 21-53 of the Tempe City Code. I also request that the abatement be approved for 180 days.

We are requesting Hearing Officer Authorization to abate this public nuisance in accordance with Section 21-53 of the Tempe City Code by removal and repair of:

Landscaping that is substantially dead, damaged or characterized by uncontrolled growth, or presents a deteriorated or slum-like appearance; or any dead trees, bushes, shrubs or portions thereof, including stumps

As owner of the property, you have thirty (30) days after receipt of this letter to abate or correct any violation as described below. If the violation(s) have not been corrected, our office will proceed with the abatement process.

CC 21-3.b.8

Remove all grass and weeds from the gravel landscape in the front and sides of the property.

Upon receipt of the Hearing Officer approval to abate this public nuisance, the necessary work will be performed at the expense of the property owner. The cost of this work will be \$606.49. In addition to the actual cost of abatement, an administrative charge of fifteen percent (15%) of the actual cost of abatement or three hundred (\$300) dollars, whichever is greater, for expenses incurred by the city for abatement procedures, and the cost of recording liens and releases will be charged. The recorded lien may bear interest at the legal rate of judgments in the State of Arizona. Administrative charges and the cost of recording liens and releases shall become a lien on the property whether or not the public nuisance is abated by the City.

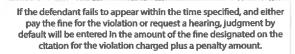

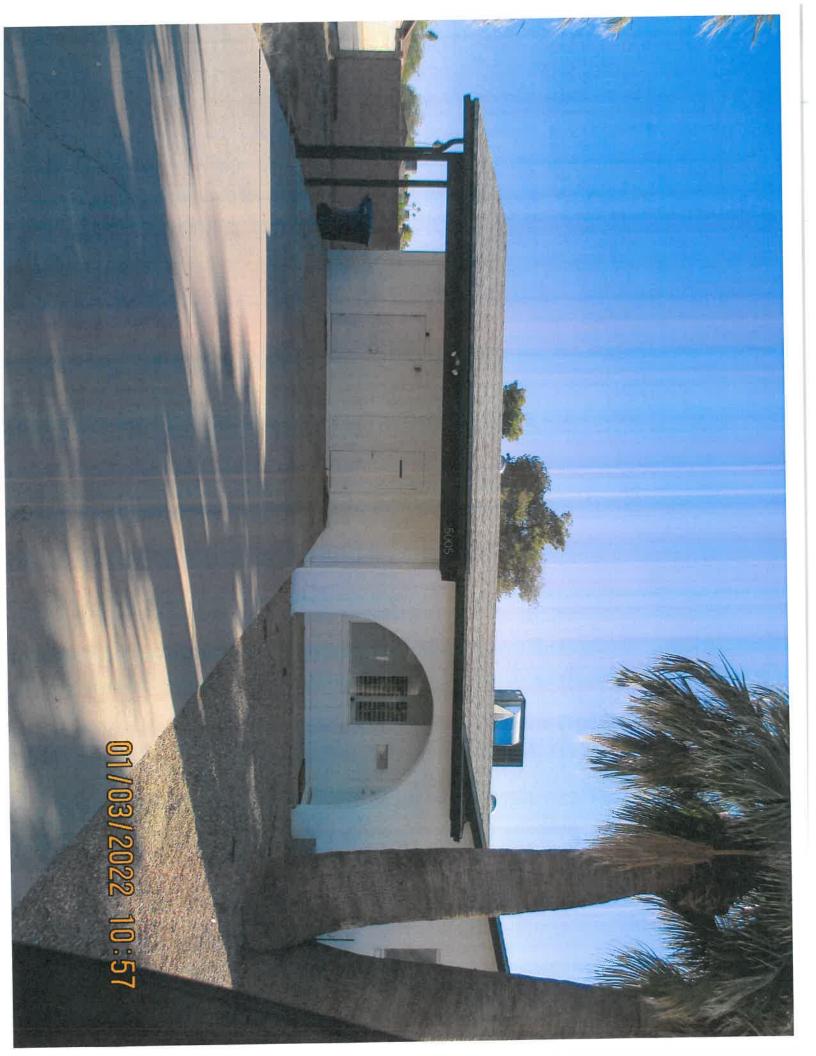

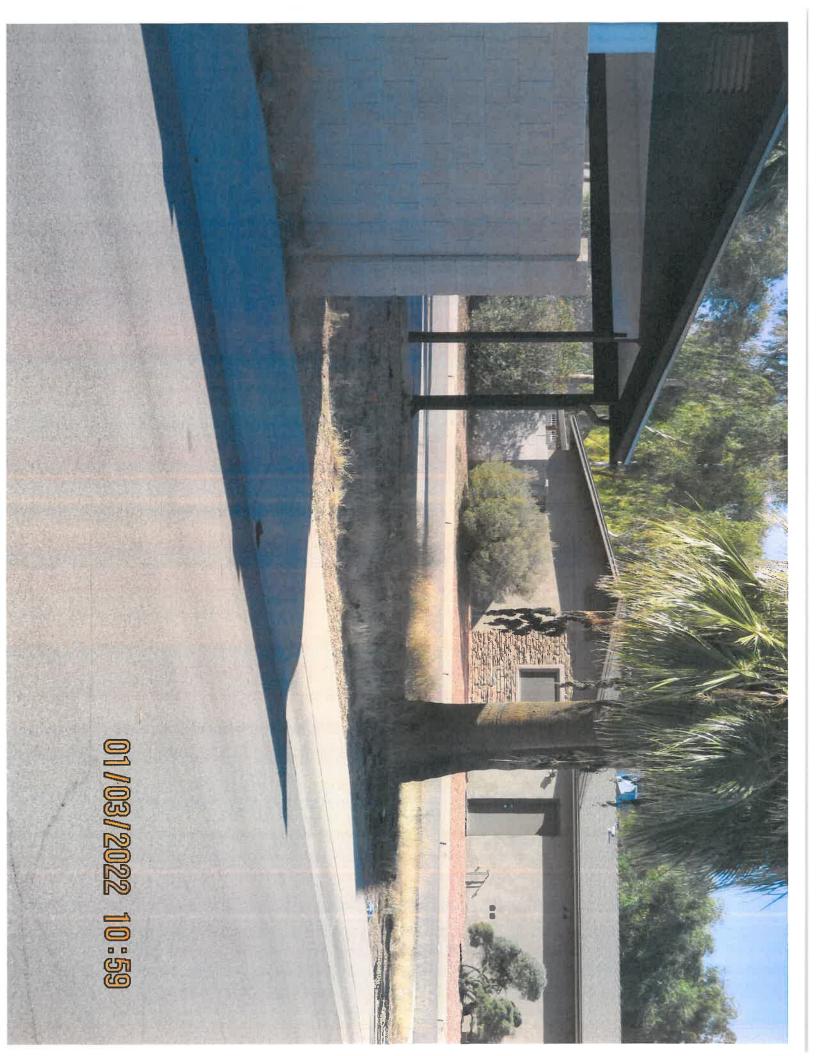
