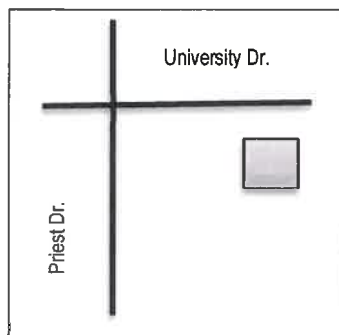

ACTION: Request approval to abate public nuisance items at the Williams Property located at 1045 W. 9th Street. The applicant is the City of Tempe – Code Compliance.

FISCAL IMPACT: \$1425 for abatement request: remove trash and debris from exterior areas of the property.

RECOMMENDATION: Staff – Approval of 180-day open abatement

BACKGROUND INFORMATION: City of Tempe – Code Compliance Section requests approval to abate items in violation of the Tempe City Code at the WILLIAMS PROPERTY. The details of this case represent several months of correspondence for compliance with the property owner. Staff requests the approval of abatement of the following nuisance items under Complaint CE217221: remove trash and debris from exterior areas of the property.

COMMENTS:

Code Compliance is requesting approval to abate the Williams Property located at 1045 W. 9th Street, in the R1-6, Single Family Residential district. This case was initiated 12/01/2021, after which Code Compliance has attempted to obtain compliance through correspondence with the property owner regarding violations of the Tempe City Code.

Without the intervention of abatement, the property will continue to deteriorate. It is therefore requested that the City of Tempe Community Development Hearing Officer approve a 180-day open abatement of this public nuisance in accordance with Section 21-53 of the Tempe City Code.

FINDINGS:

On 12/01/2021 I inspected the above property and found tall grass and weeds in the front and side gravel landscape areas and trash and debris items in the carport / driveway area. I sent an initial notice to the owner.

On 12/15/2021 I reinspected the property and found that the violations had not been corrected. I sent a final notice.

On 12/29/2021 I reinspected the property and found that the violations were not corrected. I put a pink placard on the door of the residence requesting compliance or contact by 01/04/2022 in order for a citation to be avoided.

On 01/04/2022 I reinspected the property and found that the violations had not been corrected. I was not contacted by the owner. I issued a citation for the violations.

On 02/23/2022 I reinspected the property and found that the grass and weeds had been removed, but the trash and debris items in the carport / driveway area remained. Cabinets were installed in the carport, and it appeared some of the items had been removed or stored properly. I monitored the property.

On 04/14/2022 I reinspected the property and found that there were still multiple trash and debris items in the carport / driveway area. I issued a second citation.

On 05/17/2022 I issued a notice of intent to abate on the property.

RECOMMENDATIONS:

I recommend an abatement of the nuisance violations at the property at 1045 W 9th St. due to property owner's failure to bring property into compliance with Tempe City Code 21-3.B.8. The owner, Mr. Williams, was given ample time to come into compliance and maintain the property. Two citations have been issued, and although Mr. Williams has paid them, the violations have not been corrected. There is no indication that the property will be brought into compliance in the near future. The property represents a health hazard and an eyesore to the community.

Without the intervention of abatement, the property will continue to deteriorate. I therefore make a request to the City of Tempe Community Development Hearing Officer for authorization to abate this public nuisance in accordance with section 21-53 of the Tempe City Code and authorization of multiple abatements for a period not to exceed one hundred eighty (180) days from the previous abatement order.

This office will submit this complaint to the Community Development Abatement Hearing Officer located at the Tempe City Council Chambers on 06/21/2022. We are requesting Hearing Officer Authorization to abate this public nuisance in accordance with Section 21-53 of the Tempe City Code by removal and repair of:

CC 21-3.b.1 Filthy, littered, debris or trash-covered exterior areas, including exterior areas under any roof not enclosed by the walls, doors or windows of any building.

If the violations have not been corrected within thirty days, our office will proceed with the abatement process. As owner of the property, you have thirty (30) days after receipt of this letter to abate or correct any violation as described below:

- 1. REMOVE ALL TRASH AND DEBRIS FROM THE CARPORT, DRIVEWAY, AND ALL YARD AREAS OF THE RESIDENCE. (INCLUDING, BUT NOT LIMITED TO TOOLS, STORAGE TUBS, BOXES, MISC. HOUSEHOLD ITEMS, BOTTLES, CANS, AND VARIOUS OTHER ITEMS.)**

Upon receipt of the Hearing Officer approval to abate this public nuisance, the necessary work will be performed at the expense of the property owner. The cost of this work will be **\$1425.00**. In addition to the actual cost of abatement, an administrative charge of fifteen (15) percent of the actual cost of abatement or three hundred (\$300) dollars, whichever is greater, for expenses incurred by the city for abatement procedures, and the cost of recording liens and releases will be charged. The recorded lien may bear interest at the legal rate for judgments in the State of Arizona. Administrative charges and the cost of recording liens and releases shall become a lien on the property, whether or not the public nuisance is abated by the City.

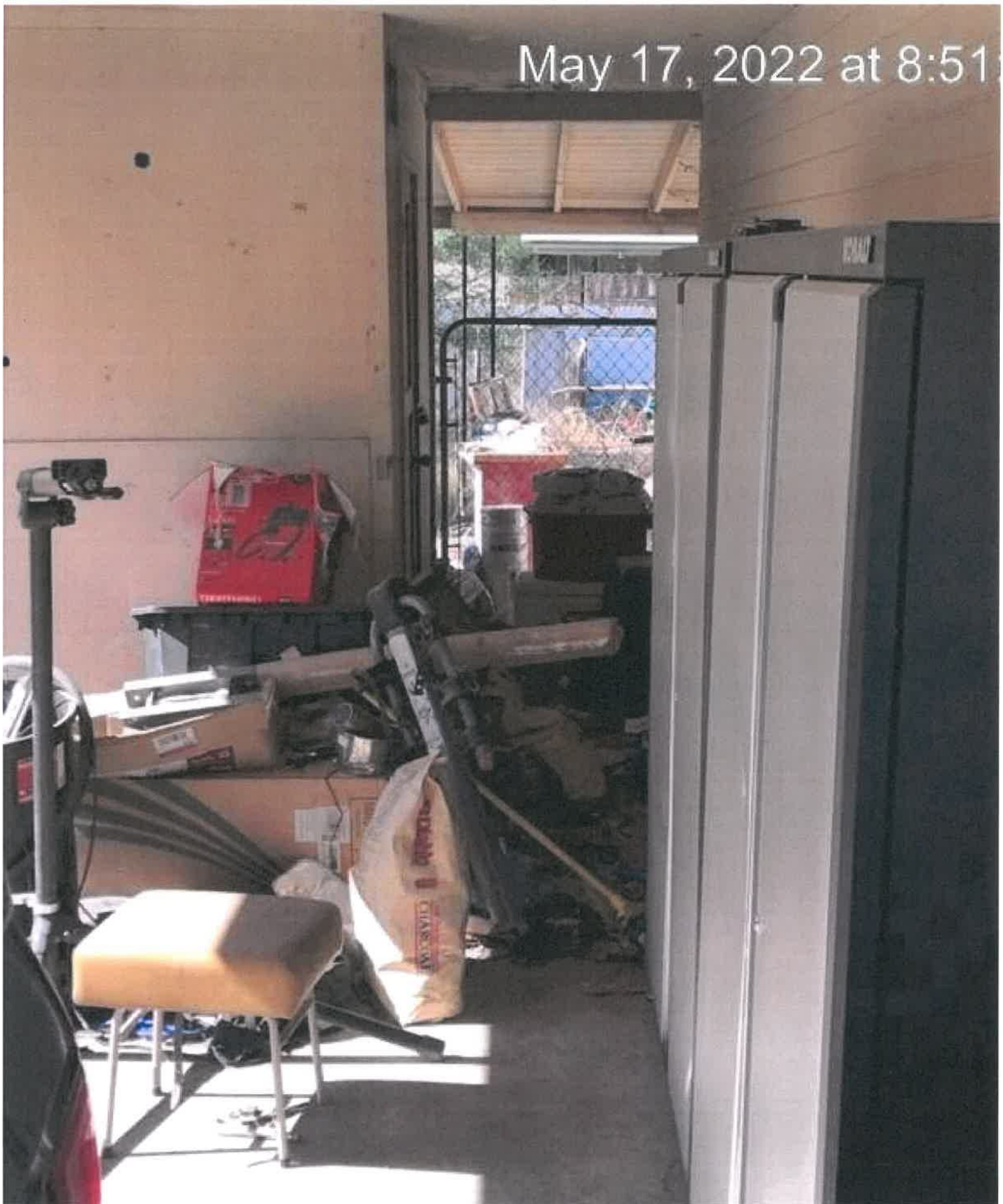

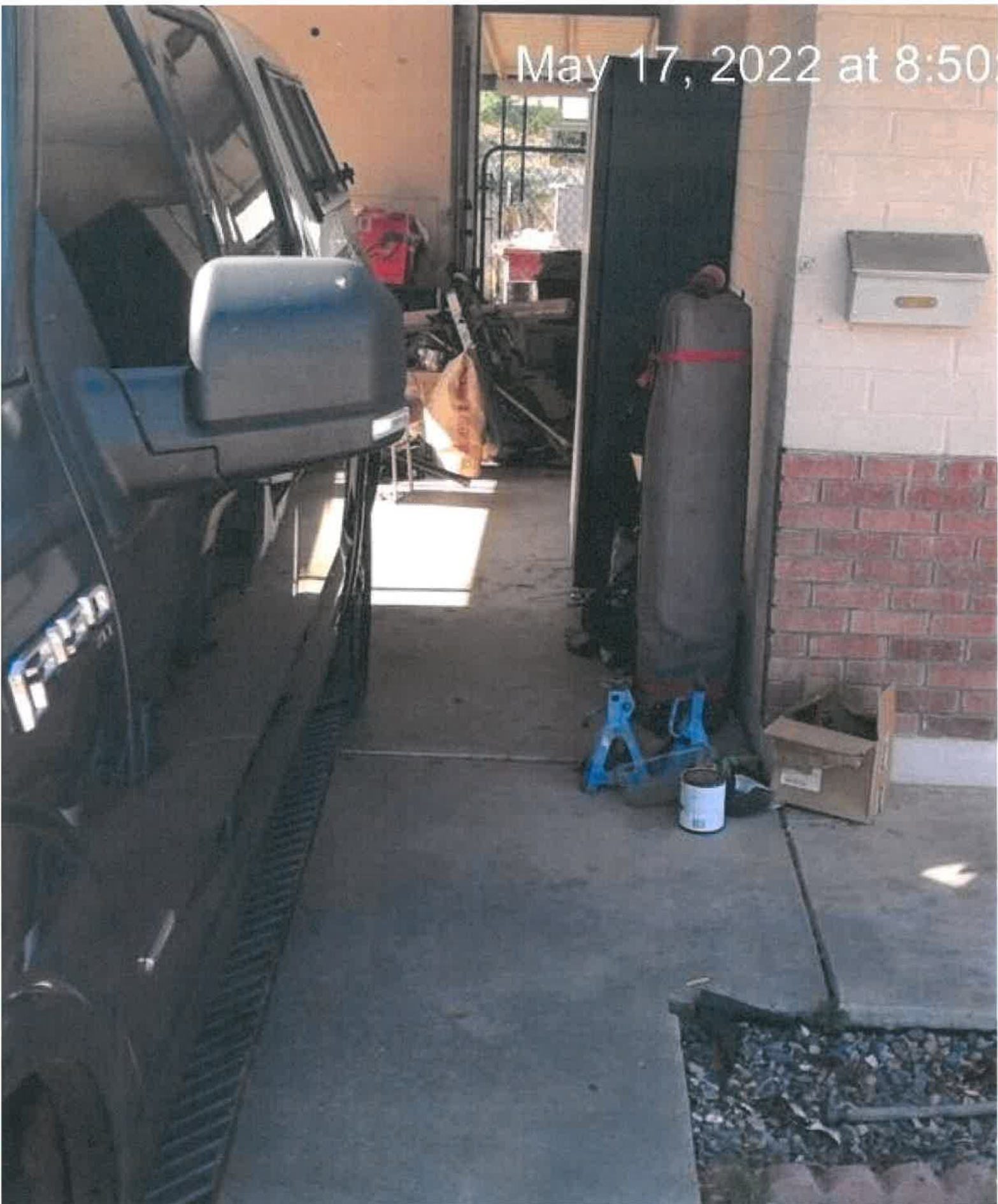
