
Agenda Item: 3

ACTION: Request approval to abate public nuisance items at the Rancho Tempe Property located at 4605 S. Priest Drive #222. The applicant is the City of Tempe – Code Compliance.

FISCAL IMPACT: \$6989 for abatement request: remove junk, debris and stored items from exterior areas of the residence.

RECOMMENDATION: Staff – Approval of 180-day open abatement

BACKGROUND INFORMATION: City of Tempe – Code Compliance Section requests approval to abate items in violation of the Tempe City Code at the RANCHO TEMPE PROPERTY. The details of this case represent several months of correspondence for compliance with the property owner. Staff requests the approval of abatement of the following nuisance items under Complaint CM220215: remove junk, debris and stored items from exterior areas of the residence.

COMMENTS:

Code Compliance is requesting approval to abate the Rancho Tempe Property located at 4605 S. Priest Drive #222, in the RMH, Mobile Home Residence district. This case was initiated 02/04/2022, after which Code Compliance has attempted to obtain compliance through correspondence with the property owner regarding violations of the Tempe City Code.

Without the intervention of abatement, the property will continue to deteriorate. It is therefore requested that the City of Tempe Community Development Hearing Officer approve a 180-day open abatement of this public nuisance in accordance with Section 21-53 of the Tempe City Code.

RECOMMENDATIONS:

I recommend an abatement of the nuisance violations at the property at 4605 S Priest Dr, due to tenant's failure to bring property into compliance with Tempe City Code 21-3.b.1. RANCHO TEMPE MOBILE HOME PARK LLC / SHADDI GARCIA has been given ample time to come into compliance and maintain the property. The tenant has been issued a civil citation and has failed to appear to court. The property has not been previously abated for the same matters. There has been no indication that the tenant will bring the property into compliance. The property represents an eyesore to the community.

Without the intervention of abatement, the property will continue to deteriorate. I therefore make a request to the City of Tempe Community Development Hearing Officer for authorization to abate this public nuisance in accordance with section 21-53 of the Tempe City Code and authorization of multiple abatements for a period not to exceed one hundred eighty (180) days from the previous abatement order.
