

**ACTION:** Request approval to abate public nuisance items at the Invitation Homes Property located at 2418 S. Cottonwood Drive. The applicant is the City of Tempe – Code Compliance.

FISCAL IMPACT: \$886 for abatement request: front and side landscape cleanup.

**RECOMMENDATION**: Staff – Approval of 180-day open abatement

<u>BACKGROUND INFORMATION</u>: City of Tempe – Code Compliance Section requests approval to abate items in violation of the Tempe City Code at the INVITATION HOMES PROPERTY. The details of this case represent several months of correspondence for compliance with the property owner. Staff requests the approval of abatement of the following nuisance items under Complaint CE221091: front and side landscape cleanup.

#### **COMMENTS:**

Code Compliance is requesting approval to abate the Invitation Homes Property located at 2418 S. Cottonwood Drive, in the R1-6 Single Family Residential district. This case was initiated 02/16/2022, after which Code Compliance has attempted to obtain compliance through correspondence with the property owner regarding violations of the Tempe City Code.

Without the intervention of abatement, the property will continue to deteriorate. It is therefore requested that the City of Tempe Community Development Hearing Officer approve a 180-day open abatement of this public nuisance in accordance with Section 21-53 of the Tempe City Code.

#### FINDINGS:

02/16/2022 The Code Compliance Division received a complaint for deteriorated landscape, trash and debris, and unregistered vehicle. I inspected property and observed deteriorated landscape with grass and weeds growing in the gravel landscape in the front and side yards along with trash in the front and side yards. I also observed an unregistered Malibu car AZ license plate CSS6148 10/20 in the driveway. Notice to comply mailed to owner, property manager, and tenant.

02/25/2021 The Code Compliance Division received an additional complaint for deteriorated landscape, inoperable vehicle, over height grass and weeds along with lawn parking.

03/10/2022 I inspected property and found landscape to be even more deteriorated and the unregistered vehicle still in the driveway. Mailed final notice to comply to owner, property manager, and tenant.

03/24/2022 Posted notice to property to comply or contact me 03/29/2022.

03/29/2022 I inspected the property and spoke with the tenant Chantel Randolph. Ms. Randolph asked for an extension due to personal reasons. I granted her an extension and let her know that a citation would be issued 04/13/2022 if violations were not corrected.

05/02/2022 I spoke with the new property manager and granted an extension.

05/16/2022 Tenant and Property Manager did not contact me and the landscape was

still deteriorated therefore, a Civil Citation was issued.

05/18/2021 The Code Compliance Division received an additional complaint for deteriorated landscape.

06/01/2022 Owner failed to appear for court.

06/10/2022 Posted notice of intent to abate to property and mailed to property owner, property manager, and tenant.

#### **RECOMMENDATIONS:**

I recommend an abatement of the nuisance violations at the property at 2418 S. Cottonwood Dr. due to property owner's failure to bring property into compliance with Tempe City Code 21-3.B.8. 2017-2 IH BORROWER LP has been given ample time to come into compliance and maintain the property. The tenant has been issued a civil citation and has failed to appear to court for the citation. There has been no indication that the property owner will bring the property into compliance. The property represents a health hazard and an eyesore to the community.

Without the intervention of abatement, the property will continue to deteriorate. I therefore make a request to the City of Tempe Community Development Hearing Officer for authorization to abate this public nuisance in accordance with section 21-53 of the Tempe City Code and authorization of multiple abatements for a period not to exceed one hundred eighty (180) days from the previous abatement order.

We are requesting Hearing Officer Authorization to abate this public nuisance in accordance with Section 21-53 of the Tempe City Code by removal and repair of:

Any landscaping, visible from public property, that is substantially dead, damaged, or characterize by uncontrolled growth, or presents a deteriorated appearance

As owner of the property, you have thirty (30) days after receipt of this letter to abate or correct any violation as described below. If the violation(s) have not been corrected, our office will proceed with the abatement process.

REMOVE GRASS AND WEEDS FROM FRONT AND SIDE YARDS.

GRAVEL LANDSCAPE MUST BE MAINTAINED FREE OF GRASS AND WEEDS.

Upon receipt of the Hearing Officer approval to abate this public nuisance, the necessary work will be performed at the expense of the property owner. The cost of this work will be \$886.00. In addition to the actual cost of abatement, an administrative charge of fifteen percent (15%) of the actual cost of abatement or three hundred (\$300) dollars, whichever is greater, for expenses incurred by the city for abatement procedures, and the cost of recording liens and releases will be charged. The recorded lien may bear interest at the legal rate of judgments in the State of Arizona. Administrative charges and the cost of recording liens and releases shall become a lien on the property whether or not the public nuisance is abated by the City.




