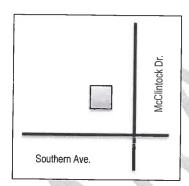
Agenda Item: 2

ACTION: Request approval to abate public nuisance items at the Bay Property located at 1509 E. Del Rio Drive. The applicant is the City of Tempe – Code Compliance.

FISCAL IMPACT: \$890.00 for abatement request, front and side yard landscape cleanup, remove junk, trash, debris and stored items from front yard and driveway.

RECOMMENDATION: Staff – Approval of 180-day open abatement

<u>BACKGROUND INFORMATION</u>: City of Tempe – Code Compliance Section requests approval to abate items in violation of the Tempe City Code at the BAY PROPERTY. The details of this case represent several months of correspondence for compliance with the property owner. Staff requests the approval of abatement of the following nuisance items under Complaint CE220242: front and side yard landscape cleanup, remove junk, trash, debris and stored items from front yard and driveway:

COMMENTS:

Code Compliance is requesting approval to abate the Bay Property located at 1509 E. Del Rio Drive in the R1-6, Single Family Residential District. This case was initiated 01/11/22 following which Code Compliance has attempted to obtain compliance through correspondence with the property owner regarding violations of the Tempe City Code.

Without the intervention of abatement the property will continue to deteriorate. It is therefore requested that the City of Tempe Community Development Hearing Officer approve the 180-day open abatement of this public nuisance in accordance with Section 21-53 of the Tempe City Code.

FINDINGS:

01/11/2022 Inspected property and found unregistered black Jeep Cherokee AZ WCA1CYA lawn parking on front yard landscape. Notice to comply mailed to owner.

01/26/2022 The Code Compliance Division received an additional complaint for trash and debris.

01/27/2022 Inspected property and found the vehicle still lawn parking. I also observed the house under renovation with trash and debris in the yard and driveway. Mailed notice to comply to owner.

02/10/2022 Inspected property and observed further deterioration. Mailed final notice to owner to comply.

02/17/2022 The Code Compliance Division received an additional complaint for trash and lawn parking.

02/24/2022 Inspected property and observed property still in violation with lawn parking along with trash and debris. I knocked on the door to contact the owner. I heard people talking but no one answered the door. Hung pink compliance or contact placard on the door for the owner.

02/25/2022 Inspected property and the unregistered vehicle had been removed from the property and the trash and debris improved.

03/08/2022 The Code Compliance Division received an additional complaint for holes in

roof and over height grass and weeds.

03/11/2022 Inspected property and observed it was being actively renovated. Unregistered vehicle returned, grass and weeds in front yard landscape, and trash and debris in driveway. Posting final notice to property.

03/14/2022 I knocked on door to contact owner. No one answered. I posted final notice to property. Black unregistered vehicle in the driveway.

03/14/2022 The Code Compliance Division received an additional complaint for deteriorated landscape, junk, trash and debris, lawn parking, and deteriorated roof.

03/21/2022 Neighbor Ashton Ferris called and spoke with me regarding his concerns about this property. He mentioned drug use and a garage fire caused from an electrical problem.

03/25/2022 Inspected property and observed no improvement along with new violations. Mailed and posted final notice to property with all violations: unregistered vehicle, lawn parking, trash and debris, deteriorated landscape, deteriorated exterior paint, deteriorated roof, and broken windows. I knocked on the door again and no one answered.

04/11/2022 The Code Compliance Division received an additional complaint for homeowner living in condemned home.

04/27/2022 Inspected property and property further deteriorated. Tiles off roof, front windows broken, deteriorated landscape which includes grass and weeds in gravel front yard, trash and debris, vehicle did get registered and at the time was on a jack stand. Owner failed to contact me. First Civil Citation issued. Mailed certified and regular mail.

05/11/2022 Owner failed to appear for court

05/18/2022 Property had not improved. Owner did not contact me. Second Civil Citation issued for trash and debris, deteriorated landscape, deteriorated paint, deteriorated roof and broken windows. Posted to property.

06/02/2022 First Civil Citation that was sent certified mail came back. I posted to property. I put my business card with the citation.

06/10/2022 Inspected property observed no improvement. Owner has not contacted me. Owner failed to appear in court for first and second Citations. Third Civil Citation issued for trash and debris, deteriorated landscape, deteriorated paint, deteriorated roof and broken windows. Posting to property.

06/13/2022 When I went to property to post the Third Civil Citation, Officer Brandon Lundberg with the Tempe Police Dept. was there for a police matter regarding animal cruelty. I spoke with Officer Lundberg about the history of the complaints. Later that day he sent me three possible phone numbers for the owner. While we were talking the

neighbor across the street came out to speak with us. She stated she had just spoke with Warren Bay and he stated he was going to sell the house and had someone interested.

06/28/2022 Inspected property with no improvement. Owner failed to appear in court for Third Civil Citation. I tried contacting Warren Bay with the phone numbers Officer Lundberg provided me. I left a voicemail on 480-730-8130, I received a busy signal for 480-886-3688, and there was no answer on 480-577-6177.

07/11/2022 I attempted to contact owner again by phone without success. Criminal packet submitted for Warren Bay due to lack of compliance.

07/19/2022 Posted notice of intent to abate to property and mailed to property owner.

RECOMMENDATIONS:

I recommend an abatement of the nuisance violations at the property 1509 E Del Rio Dr. due to property owner's failure to bring property into compliance with Tempe City Code 21-3.B.8 and 21-3.B.1. Mr. Bay has been given ample time to come into compliance and maintain the property. The property owner has been issued 3 civil citations and has failed to appear to court. There has been no indication that the property owner will bring the property into compliance. The property represents a health hazard and an eyesore to the community.

Without the intervention of abatement, the property will continue to deteriorate. I therefore make a request to the City of Tempe Community Development Hearing Officer for authorization to abate this public nuisance in accordance with section 21-53 of the Tempe City Code and authorization of multiple abatements for a period not to exceed one hundred eighty (180) days from the previous abatement order.

As owner of the property, you have thirty (30) days after receipt of this letter to abate or correct any violation as described below. If the violation(s) have not been corrected, our office will proceed with the abatement process.

WILDFLOWERS PERMITTED.

Upon receipt of the Hearing Officer approval to abate this public nuisance, the necessary work will be performed at the expense of the property owner. The cost of this work will be **\$890.00**. In addition to the actual cost of abatement, an administrative charge of fifteen percent (15%) of the actual cost of abatement or three hundred (\$300) dollars, whichever is greater, for expenses incurred by the city for abatement procedures, and the cost of recording liens and releases will be charged. The recorded lien may bear interest at the legal rate of judgments in the State of Arizona. Administrative charges and the cost of recording liens and releases shall become a lien on the property whether or not the public nuisance is abated by the City.

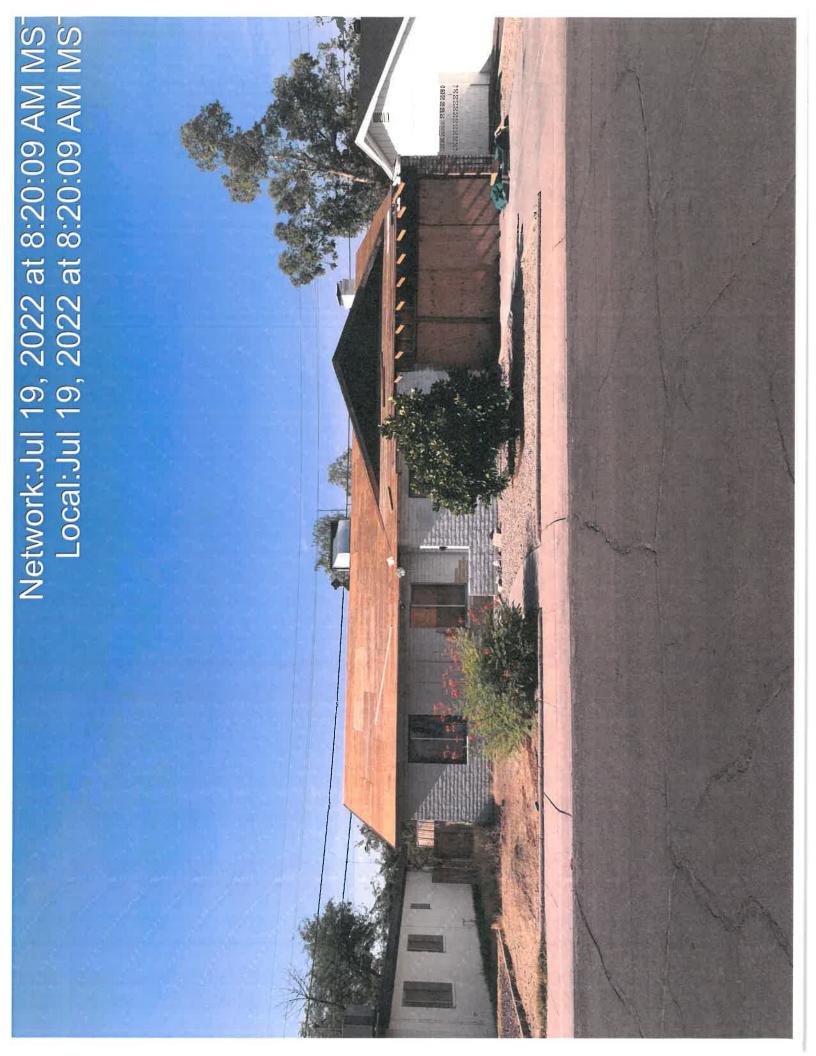

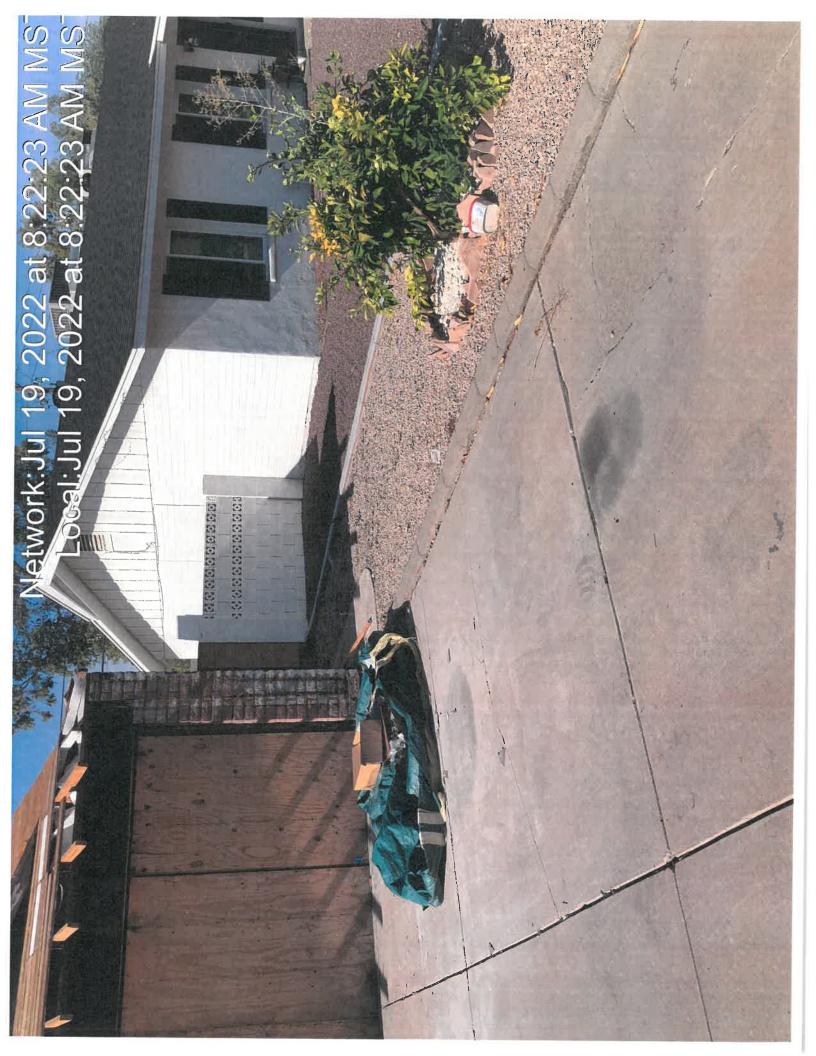

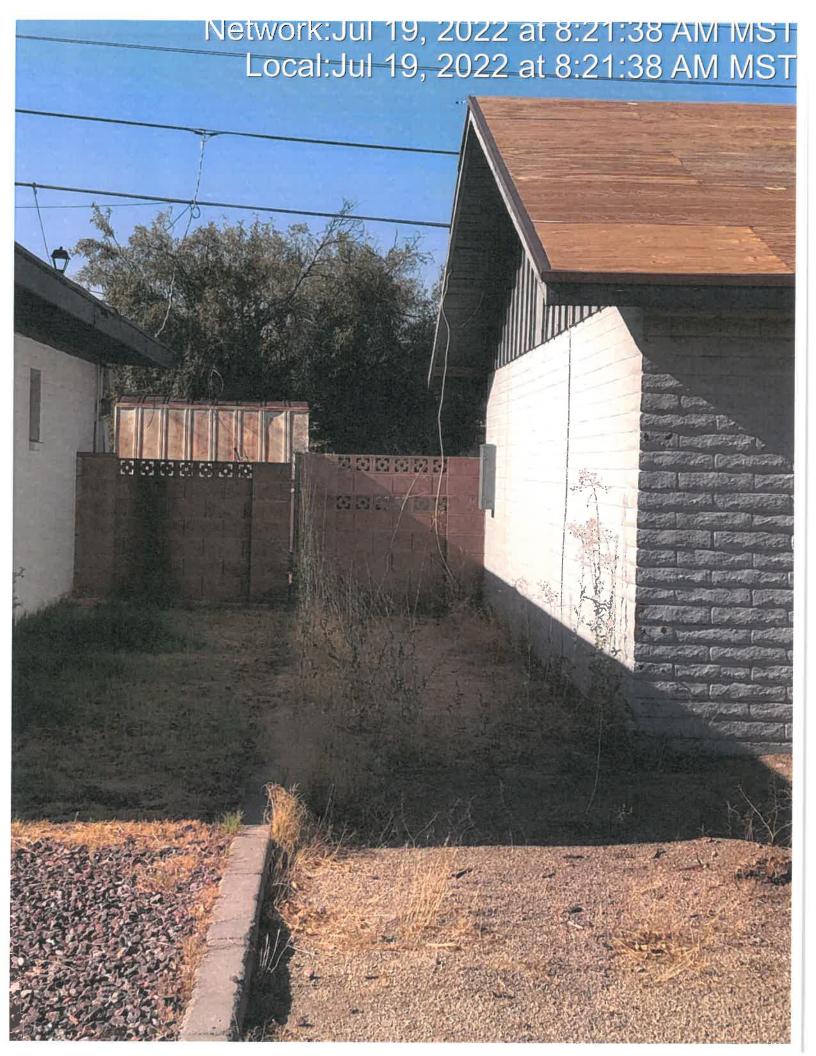
