Water Resources Development Act Passage, Kyrene Reclamation Facility

Today, the Water Resources Development Act (WRDA) was signed into law. Link to bill is here. The bill includes the WRDA designation for the Kyrene Water Reclamation Facility and opens future opportunities for \$37.5 million in federal funding. The 10/27/22 Weekly Information Packet memo included the letter of interest Mayor Woods submitted to the Army Corps of Engineers urging support for the Kyrene Reclamation Facilities and Improvements Capital Program. Information on the federal visit to the facility was included in the 9/2/22 Weekly Information Packet. Earlier efforts on the WRDA designation were included in the 5/20/22 Weekly memo.

FY 2023 Community Project/Congressionally Directed Funding Requests Update

The 6/24/22 Weekly Information Packet and earlier memos noted the 2 Tempe Congressionally Directed Funding requests that were advanced by Congressman Stanton's office and supported by Arizona Senators: funds toward affordable workforce housing and funds toward the College Avenue/University Drive underpass. This week, the FY 23 omnibus Appropriations bill was passed that includes the funding for these projects. Press release from Congressman Stanton's Office is here. Although the bill has not been signed as of this writing, the expectation is that it will be signed by the President.

Background: <u>The FY 23 Transportation</u>, <u>Housing and Urban Development funding bill</u> includes both Tempe projects. The projects are listed on page 32 and page 133 at this link.

Federal Funding for Transit Programs

Via Valley Metro, 12/23/22, excerpted

For several months, Valley Metro has been working with Congressman Stanton, Congressman Gallego, Senator Kelly, Senator Sinema, and our partners at the City of Phoenix to secure additional federal funding through the FY23 Transportation, Housing and Urban Development (THUD) appropriations bill to support the South Central Extension/Downtown Hub and Northwest Phase II light rail projects, and our zero emission bus program.

I am pleased to report that the final bill language includes an additional \$21 million in funding for the South Central Extension/Downtown Hub project. Unfortunately, the Northwest Extension II project will not receive additional funding in this bill because it did not meet the final bill criteria. We are also thrilled that the Valley will receive an earmark of \$4 million to support our zero emission bus program. This is a big win as we work together with our regional partners to create a more environmentally sustainable transit fleet.

The House and Senate are expected to vote on the bill today before it goes to President Biden for his signature. Subsequently, the Federal Transit Administration (FTA) would administer the funding.

Legislative Housing Supply Ad Hoc Committee

As noted in an earlier weekly memo, Mayor Woods was named to the Housing Supply Study Committee, an ad hoc committee created by the legislature. The final committee meeting was this week, 12/20/22. A video of the final committee hearing is at this link, which includes Mayor Woods' policy recommendations for legislative policies to support guaranteed affordable housing.

Background: Striker language to HB 2674 was passed and signed into law which authorized a study committee to analyze housing supply with representatives representing different stakeholder groups. The committee discussed and received presentations on areas including industry and city processes, economic impacts of housing, housing accessibility for veterans, LGBTQ individuals, seniors, and minority communities, and housing supply chain concerns. SUBJECT: Updated Requirements for Permitting Temporary Liquor Extension of Premises



PURPOSE:

The purpose of this memo is to update Mayor and Council of the Special Events Task Force Committee (SETFC) approval process for temporary extension of premises requests.

CITY COUNCIL STRATEGIC PRIORITY:



2.21 - Achieve ratings of "Very Satisfied" or "Satisfied" with the availability of information about city programs, events, services, and issues greater than or equal to the top 10% of the national benchmark cities as measured in the Community Survey.

BACKGROUND:

The Arizona Revised Statutes (ARS) 4-207.03 administers the process for a business that is in possession of a liquor license to temporarily extend their premises beyond the licensed area onto private property or into city rights-of-way. In October 2022, this statute received a legislative change that will affect the process for obtaining approval for this temporary extension, and therefore affect the City of Tempe's permitting process. According to ARS 4-207.03, licensed businesses applying for a temporary Extension of Premises permit are required to obtain approval from the Local Governing Board prior to being granted a permit from Arizona Department of Liquor Licenses and Control (DLLC). The SETFC serves as the City of Tempe's Local Governing Board and provides that initial approval.

Temporary Extensions of Premises require oversight by the SETFC. For example, when a business extends their premises with a temporary structure, the Tempe Medical Fire Rescue Department (TMFRD) must conduct an inspection of the structure. The TMFRD will also assign an occupancy for the space. If the business is extending onto private property, the business must provide to the SETFC written approval from the property management company or property owner. When the extension of premises takes place on public property, the SETFC will ensure that appropriate certificates of insurance are obtained. The SETFC must also review and approve liquor control plans & security plans, and consider potential impacts to surrounding businesses or residences

OVERVIEW OF LEGISLATIVE CHANGE:

Per the October 2022 legislative change, licensed businesses are now only required to obtain one approval from the Local Governing Board for a 12-month period; therefore, businesses can add additional extensions of premises or modify their approved extensions after the SETFC has reviewed and approved the initial request. The DLLC does requires businesses to notify them in writing 10 days in advance of any additional extensions of premises or when there will be modifications to approved extensions. The Local Governing Board will not be notified when these additions or changes are made.

ADDITIONAL REQUIREMENTS:

The SETFC is supportive of the change to ARS 4-207.03 and the development of a streamlined process for Tempe businesses to temporarily extend their liquor licensed premises. In order to maintain a safety-centered focus, and to adhere to City of Tempe codes and any applicable state and federal laws, the SETFC will be approving temporary extensions of premises for up to a three (3) month period. Businesses may return to the SETFC to obtain additional 3-month approvals. Any modifications to previously approved temporary extensions will also require approval by the SETFC.

Updated Requirements for Permitting Temporary Liquor Extension of Premises

The temporary extensions of premises permits are not intended to bypass or replace the Community Development permanent extension of premises process. The SETFC will continue to monitor temporary extensions of premises and will consult with the appropriate city representatives to determine if a permanent extension of premises should be obtained.



IBCCES— THE JOURNEY TO BECOMING AN AUTISM CERTIFIED CITY

In 2021 the Community Services Department took steps to initiate the accreditation of a Certified Autism Center (CAC) through International Board of Credentialing and Continuing Standards (IBCCES). One hundred and twenty (120) Community Services employees went through individual trainings to better understand those with autism and their families.

In addition, five locations and six parks received site reviews. Tempe was the first city in the world accredited by IBCCES to include a significant focus on parks. We understand the essential value of play for all ages and abilities within our community.

Each location received a Sensory Guide specific to their location including guidelines on how to have our spaces become more inclusive and suggestions for adaptations in our buildings and parks, for those with intellectual and developmental disabilities and their families.

Certified Locations:

Tempe Public Library, Tempe Town Lake, History Museum, Edna Vihel, Arts Center and Kiwanis Recreation Center

Certified Parks:

Kiwanis Park, Daley Park, Estrada Park, Indian Bend Park, Creamery Park and Tempe Sports Complex

As we implement strategies from the Parks & Recreation Master Plan, we are bringing this knowledge into our meetings and discussions knowing that play should not be restricted but embraced. Implementing these suggested resources and recommendations has allowed us to think outside the box when embracing and engaging play in an inclusive and innovative way.

Accreditation for Community Service Department

On May 10, 2021, the Community Services Department received the CAC accreditation with 80% of all department employees successfully completing an online training that focused on learning about those with autism, the neurological aspects of the diagnosis and how to best support this population and their families as they travel and live in our city.

The Future

Efforts were expanded to other City departments and on November 29, 2022, the City of Tempe as a local government entity received its CAC accreditation by partnering with the Tempe Police Department, Tempe Fire Medical Rescue Department, Office of Education, Career and Family Services: Kid Zone and Human Resources: Employee Development for our new hires. Over 400 employees in the above departments have completed trainings.

The next goal is to reach Autism Certified City (ACC) accreditation by the end of 2023 by partnering with small businesses, tourism, corporate and neurodiverse workplaces within the community. This creates a wide reach outside our government entity and the opportunity to create a fully inclusive city.
